The Traill County Board of Commissioners came to order on November 3, 2015 at 8:00 a.m. with all members present.

On motion of Elliott, seconded by Nesvig and carried to approve the minutes of October 20, 2015 as presented.

Glenda Haugen, Deputy County Auditor met with the commission to present the 2016 Dental & Vision rates from Blue Cross/Shield. Haugen also requested that the commission make a change to the current contract to reflect a starting date of the 1st of the month following the date of hire effective January 1, 2016. On motion of Larson, seconded by Nesvig and carried to grant the request. Haugen also presented a change to the flexible spending account which would reflect the employee could carry a \$500.00 credit into the next year. The commission directed that the current flexible spending account be left as is.

Kalya Knudson, Tax Director presented an abatement filed by Matthew & Teresa Kamphaug for the property they own on the N 150' of Lot 9 SE½ Section 18-148-53 A-.44. Kamphaug had requested an abatement for tax years 2013 & 2014. On motion of Amb, seconded by Larson and carried to deny the request as the City of Hatton had done.

Stuart Larson, States Attorney met with the commission to present a draft of an easement with Timothy L & Nancy L Schumacher for the abandon cemetery in Morgan Cemetery. On motion of Larson, seconded by Nesvig and carried to allow the county to sign the easement as presented and to have it recorded in the Recorders Office when the Easement is signed.

The commission discussed the Nielsville Bridge. NDDOT told the commission that if the county wanted to divert all the funds available received from the state the county could do that, however the state would have no money of its own to put towards the replacing of the Nielsville Bridge. Commissioner Nesvig requested that a letter be written from the Commission to the NDDOT requesting assistance for funding of the bridge and also that the Commission contact Polk County to see where their Commission sits with this issue. On motion of Nesvig, seconded by Amb to allow the County Commission to send a letter out to the NDDOT requesting funding for the bridge. Commissioners Nesvig and Amb voting Aye; Commissioners Eblen, Elliott and Larson voting Nay. Motion failed. The Commission directed the County Auditor to get in touch with the Polk County Commission to meet with the commission at their next regular meeting.

Kim Jacobson, Social Service Director met with the commission on the Traill County Social Service Vacancy Plan. The department currently has two positions vacant. On motion of Larson, seconded by Elliott and carried to that Vacancy Plan presented be adopted as presented.

Cory Martin, Road Superintendent met with the commission on various matters. He presented a permit filed by Larry Tweten to install a culvert on the township road to meet with CR #4 in the NW¼ of Section 18 in Caledonia Township at the landowners expense. On motion of Elliott, seconded by Larson and carried to approve the permit upon the Water Board looking it over and sizing the culvert. Paving project on CR #14 is all but done except for the inspection of the haul roads which Martin will be driving to inspect.

Stuart Larson, States Attorney presented a Mutual Aid Agreement with the Grand Forks County Law Enforcement. On motion of Amb, seconded by Larson and carried to allow the county to sign the agreement. He also presented a Highway Safety Grant with the NDDOT for the period of October 1, 2015 to September 30, 2016, 100% federal funding with \$2,500.00 for Seatbelt Safety; \$2,400.00 Impaired Driving and \$1,600.00 for Underage Drinking for overtime wages. On motion of Nesvig, seconded by Amb and carried to allow the county to sign the grant as presented.

Kevin Sondreal met with the commission to give an update on the dust control project on CR #25. Grand Forks County Road Department had put out the traffic counters, those counters reflected 1100 trucks in a 24 hour period with a maximum of 1800 trucks at one day. He thanked the commission and the county road department for their help in trying to control the dust problem on CR #25.

On motion duly made and carried, the following bills presented to the Board were allowed and ordered paid, to-wit:
