The Traill County Board of Commissioners came to order on June 7, 2016 at 8:00 a.m. with the following members present: Commissioners Thomas Eblen, Kurt Elliott, Ken Nesvig, Steven Larson and Les Amb.

On motion of Eblen, seconded by Larson and carried to approve the minutes of May 17, 2016 as presented.

On motion of Larson, seconded by Nesvig and carried to allow the County Auditor to transfer \$75,000.00 from the 911 Wireless to 911.

On motion of Larson, seconded by Eblen and carried to allow the County to reissue Auditor's Warrant #85125 in the amount of \$892.75 to CH of Hillsboro Inc., DBA Country Hearth as an Indemnity Bond for Lost Instrument has been filed.

On motion of Nesvig, seconded by Amb and carried to approve the request of Craig Conner, Owner of the Barn & Grill LLC in Buxton to move his **On-Sale Only** Liquor & Beer Licenses from Buxton City to the Kris Huebner farm located in the SE<sup>1</sup>/<sub>4</sub> of Section 26 of Garfield Township for one night being June 11, 2016 (Address:  $14881 - 13^{th}$  St NE, Hatton).

On motion of Eblen, seconded by Larson and carried to allow Traill County to enter into Hepper-Olson Architects for the proposed LEC Project.

Jason Siegert, Chairman of the Traill County Water Resource District met with the County Commission to go over the Buxton Drain Project #68 and also a partial reconstruction of the Stavanger Drain #52. Commissioner Amb had received concerns from some of the Stravanger Drain #52 patrons as to how fast the water will be running from the Buxton Drain #68 into the Stavanger Drain #52. Siegert informed the commission that there will be an informational meeting concerning the Drain #52 project that will hopefully answer the questions and concerns that the patrons have. Siegert also asked permission to hold a public hearing for the snagging & clearing of the Goose River and Elm River.

Kayla Knudson, Tax Director met with the commission to present and Application for Property Tax Incentives for New or Expanding Business filed by Bjerke Partnership for the property that they own on Lot 8, Block 3 of Williams Additon to Cummings Townsite. Bjerke had asked for a 5 year, 50% exemption on the building. On motion of Eblen, seconded by Nesvig to grant the exemption as presented. Commissioners Amb and Larson voting Nay. Chairman Elliott voting Aye. Motion passed.

Mark Connelly, American Crystal Sugar and Tim Plumley, Transystems met with the commission to ask that after the CR #81 Project is completed if it would be possible to use the last ½ mile at the north end of CR #81 to run the approximately 2800 trucks out of the piling station located east of Reynolds to get onto interstate at over the 80,000 limit. Matt Lange, KLJ estimated the cost of the adding about an inch and half more pavement just to that last half mile would cost the county approximately \$75,000.00. The commission will make a decision on this matter at a later date and asked Lange to put more numbers together and get those figures to the commission.

Cory Martin, Road Superintendent met with commission on various matters. Box culverts for the CR #81 were started June 6, 2016. Chip sealing will begin June 8, 2016. The railroad tracks in Reynolds are just about completed. He presented a request from Polk County for approximately \$10,000.00 for environmental on the Nielsville Bridge. The commission will not put forth the money requested at this time. Martin will let Polk County know. Martin also addressed a letter received by Commissioner Nesvig from Todd Stenerson concerning the condition of CR #2 from CR #11 to State Hwy 200. The commission directed that high crown be taken off the road and more gravel be put on the road. Commissioner Nesvig will talk to Mr. Stenerson to inform him of the commission's decision.

The following communications were received: Copy of Leader Letter for June 2016, Copy of , letter received from ND Water Education Foundation; Copy of letter received from Senator John Hoeven concerning the Nielsville Bridge and Copy of a letter received from the Residents of Traill and Grand Forks County concerning the possibility of adding CR #25 to the TIGER Grant application as part of the Nielsville Bridge Project.
