On motion of Eblen, seconded by Amb and carried to approve the minutes of December 6, 2016 as presented.

On motion of Nesvig, seconded by Young and carried to allow the Chairman and County Auditor to sign a County Deed with Hillsboro City for the sale of property that had gone back to the county for nonpayment of taxes.

Corwyn Martin, Road Superintendent met with the commission on various matters. Working on the 2017 projects list and will present to commission at the next meeting.

Kris Bakkegard, KLJ presented an agreement for professional services for preliminary and design work on Bridge #106, work not to exceed \$67,100.00. On motion of Amb, seconded by Nesvig and carried to allow the chairman to sign the agreement as presented.

Kayla Knudson, County Tax Director presented to the board the 2017-2018 GIS Maintenance Contract with The Sidwell Company. Traill County's share is \$5,360 each year. On motion of Amb, seconded by Eblen and carried to allow the chairman to sign the Maintenance Contract as presented.

On motion of Nesvig, seconded by Young and carried to open fuel bids. Bid received from CHS Ag Services was rejected because the bidders bond was missing. On motion of Amb, seconded by Nesvig and carried to accept the bid from Buxton Farmers Union.

On motion of Eblen, seconded by Young to allow the chairman to sign the new service contracts between Traill County and F-M Ambulance Service, Inc. dba Hillsboro Ambulance Service and the West Traill Ambulance Service. Under the contracts, Traill County will pay an amount equal to 50% of the monies levied under Section 57-15-50 N.D.C.C. to each ambulance service for the 2017 tax year.

Bobbi Hepper-Olson, Architect for the LEC Project gave updates on the remodel project. On motion of Eblen, seconded by Amb and carried to approve the Alternate #1 change to add additional millwork at a cost of \$14,400.00 and Alternate #2 change to add ceramic tile flooring at a cost of \$7,600.00. On motion of Young, seconded by Eblen and carried to approve changes to add a bathroom and storage closets at a cost of approximately \$51,194.00.
