On motion of Eblen, seconded by Amb and carried to approve the following corrections: In the April 4, 2017 minutes, the total payroll was reported as \$165,411.37 and corrected to read \$232,196.27. WHEREAS, the bid in the amount of \$2,669,699.02 from Industrial Builders Inc. received in the bid opening of May 12, 2017 for Project BRC-4916(055) was the low bid received.

NOW THEREFORE, be it resolved by the Board of County Commissioners of Traill County will award to Industrial Builders Inc. the contract for Project BRC-4916(055) and hereby authorizes the Chairman of the Board to sign said contract.

It is further understood that the County shall reimburse the North Dakota Department of Transportation for any payments made under this contract, which are not collectible from the Federal Highway Administration.

The following members were present and voted aye for the adoption of the foregoing resolution: Eblen, Elliott, Nesvig, Young and Amb. The resolution was declared adopted.

On motion of Amb, seconded by Young and carried to approve a County Road Encroachment submitted by Chad Hanson on behalf of Wayne Tastad for drain tile outlet under CR #14 in the NE ¼ of section 7 in Lindaas Township.
