EMERGENCY DECLARATION: On motion of Young, seconded by Amb and carried to allow the Chairman to sign the following Emergency Declaration:

WHEREAS, the County of Traill suffered damage to trees, homes, businesses, and other public facilities caused by excessive winds and rains occurring July 11, 2017; and WHEREAS, the impact of these damages threaten the health, well-being, and public safety of citizens in the County of Traill; WHEREAS, the cost of cleanup, repair and replacement of such damaged facilities is far in excess of available County resources.

NOW, THEREFORE BE IT RESOLVED that the Board of County Commissioners declare an emergency and orders the activation and utilization of the County Emergency Operations Plan, its procedures, attachments and appendices to monitor the situation, develop a detailed damage assessment, alleviate hardship, and initiate appropriate relief actions and mitigation measures by departments and agencies of local government to limit the hardships and impact of this emergency upon the citizens of the County of Traill.

On motion of Eblen, seconded by Elliott and carried to approve the Right-Of-Way Encroachment permit filed by Century Link on county road #11 in the NE ¼ of section 6 in Hillsboro Township. Kevin Sondreal requested a cost share from the Traill County for dust control along county road 25 during harvest season with the total cost of \$35,000 being shared by Grand Forks County, Reynolds Truck Haul Committee and Traill County. On motion of Eblen, seconded by Young and carried to approve the request of \$10,000 from Traill County with the stipulation that Corwyn Martin, Road Superintendent had budgeted that amount for 2017. Mr. Sondreal will be notified after consulting with Martin.
