CORRESPONDENCE: Invitation to attend the East Central Regional Water District Annual Meeting to be held on March 27, 2018 at 7:30 p.m. in Thompson. Notice from Rebecca Hodgson, VSO that her office will be closed March 19 thru 22nd to attend ND VSO conference.

COUNTY DEEDS: On motion of Nesvig, seconded by Eblen and carried to allow the Chairman and Auditor to sign a County Deed with the City of Portland for parcel #29-0002-08890-000.

TREASURER: Connie Weber, Treasurer presented her letter of resignation. Commissioners thanks Connie for her 38 years of service to Traill County. On motion of Elliott, seconded by Nesvig and carried to accept her resignation effective April 30, 2018. On motion of Eblen, seconded by Amb and carried to appoint Carla Swanson, current Deputy Treasurer to fill the unexpired term of Connie Weber, Treasurer until the 2018 General Election. On motion of Eblen, seconded by Nesvige and carried to advertise for a full-time Deputy Treasurer.

HIGHWAY: Corwyn Martin, Road Superintendent presented a copy of a letter sent to NDDOT concerning the proposed radial-t project at the intersection of CR 14/CR9 and ND Highway 18. On motion of Amb, seconded by Nesvig and carried to allow Martin to purchase a self-propelled packer from the Butler Machinery Company in the amount of \$18,720.00. The Tiger Grant application submitted for the Nielsville Bridge has been denied. On motion of Nesvig, seconded by Elliott and carried to allow Martin to hire the part-time summer crew at \$10.00 per hour. On motion of Elliott, seconded by Eblen and carried to allow Martin to advertise for a part-time truck driver for the summer months. On motion of Nesvig, seconded by Eblen and carried by Eblen and carried to allow the Chairman and Auditor sign a County Road/Right-Of-Way Encroachment permit with American Crystal Sugar for a new approach along county road #81, in 6-148-50 Stavanger Township.

PROPERTY INSURANCE: Tabled from the March 6, 2018 Commissioner meeting and after much discussion, on motion of Nesvig, seconded by Amb and carried to approve the bid received from Lee Erickson Agency, Hillsboro for a \$2 million liability package with increasing deductibles to \$500, costing the county \$68,945.00. Lee requested a meeting with department heads to discuss a different format in which the equipment and vehicles are reported for next year's insurance bids, Haugen will set a meeting up.

TAX DIRECTOR: Kayla Knudson, Director requested permission to hire Rebecca Braaten, former Auditor on a parttime basis, to help in the Tax Director and Auditor's office, staying within the 2018 approved budget. On motion of Eblen, seconded by Nesvig and carried to allow the hiring of Braaten on a part-time basis. On motion of Nesvig, seconded by Eblen and carried to allow Knudson to advertise for a full-time Deputy Tax Director. On motion of Eblen, seconded by Elliott and carried to renew the contract with The Sidwell Company, GIS Services for a 5 year term in the amount of \$4,500.00 per year and adding the optional services of 911 Data/Addressing for a one-time setup fee of \$900.00 and a 5 year contract term at \$720.00 per year. Jerry Tollefson, Traill County's E911 Coordinator will help with the Data/Addressing portion of the contract.

SHERIFF: Steve Hunt, Sheriff and Jerry Tollefson TC E911 Coordinator discussed the new SIRN, State Radio Project. Tollefson is a voting member on the CRIB Committee and is requesting an alternate should he be unable to attend a meeting. On motion of Elliott, seconded by Nesvig and carried to appoint Steve Hunt as Traill County's alternate voting member on the CRIB Committee.

2019 BUDGET PROCESS: Tom Eblen discussed the upcoming budget process. Commissioners agreed to discuss salaries starting at their April 3, 2018 meeting and meeting with Department Heads on April 17, 2018.
