The Traill County Commissioners came to order on July 17, 2018 at 8:00 a.m. with all members present. On motion of Nesvig, seconded by Elliott and carried to approve the minutes of June 19, 2018 as presented. On motion of Eblen, seconded by Nesvig and carried to approve the 2018 Tax Equalization minutes from June 5 and June 19, 2018 as presented.

HEARING DATE: On motion of Eblen, seconded by Nesvig and carried to set September 11, 2018 at 6:00 pm for Traill County's hearing date for the 2019 Budget.

WORKSITE WELLNESS: Notice received for the July 2017-June 2018 Worksite Wellness program has been completed with 25 employees receiving an extra 8 hours of vacation for participating.

CUSTODIAN: Jenni Rubash, Custodian presented an option to increase the LP tank used by the Sheriff's Department. After reviewing the options, Rubash was instructed to contact Cenex, Portland to negotiate the cost of the 1000 gallon tank vs the 500 gallon tank and report back at the next meeting. Rubash informed the Commission of sidewalks in need of repair/replacing. Commissioners will take a look at what needs done and have Rubash bring back to the next meeting.

PLEDGE OF ASSETS: Commissioner Elliott introduced the following resolution and moved its adoption which motion was seconded by Commissioner Amb:

HIGHWAY DEPARTMENT: On motion of Eblen, seconded by Nesvig and carried to allow Corwyn Martin, Road Superintendent to open the bids for surplus property. After reviewing the bids, on motion of Eblen, seconded by Amb and carried to award the highest bidder for each property, request payment and give the proper titles to the new owner once the check has cleared the bank. Martin and Matt Lange, KLJ gave the Board updates on various road issues. On motion of Amb, seconded by Eblen and carried to allow the Chairman and County Auditor to sign a letter of financial support with NDDOT for the Build Discretionary Grant for load testing on bridge 49-125-28.0 and replacing bridge 49-112-14.0 & 49-113-14.0 for a 20% local match. On motion of Amb, seconded by Nesvig and carried to approve the five(5) Road Right-Of-Way Encroachment & Crossing permits filed by Neil Breidenbach, System Manager on behalf of East Central Regional Water District: (1) CR #25, in Section 2 NW ¼ in Morgan Township (2) CR #21, in Section 26 SW ¾ and Section 35 NW ¾ in Morgan Township (3) CR #12, Section 22 NW ¾ and Section 21 NE ¾ in Lindaas Township (4) CR #14, in Section 32 NW ¾ and Section 31 NE ¾ in Lindaas Township (5) CR #19, Section 14 SW ¾ and Section 23 NW ¾ in Lindaas Township. Steve Hunt, Sheriff was instructed to gather information on training and equipment needed for running scales on County Roads.

COUNTY ROAD 10 ISSUES: Karen Fuglesten, Hope Fuglesten, Tim Fuglesten, Ben Hershey, Dave Seyfried, Jim Skarperud, Curtis Hong, Christopher Hong, Thomas Anderson and Craig Kuck met with the Board. Martin presented a report of the dollars spent on County Road 10 dating back to 2009. Martin explained the costs involved in returning the road back into gravel, doing an overlay and doing a full reconstruction. Matt Lange, KLJ informed those attending, it is cheaper to maintain a gravel road. Lange recommended a Geo test be conducted before any work is done to insure the existing surface is able to withstand the weight of any equipment needed for repairs. Martin informed the group that patching of the road will be taken care of for now. Commissioner Eblen informed the group that any major work to be done on County Road 10 will be on hold for now because of budgets and other projects on the list.
