The Traill County Commissioners came to order on August 7, 2018 at 8:00 a.m. with the following members present: Commissioners Eblen, Elliott, Young and Amb. Commissioner Nesvig was absent. On motion of Eblen, seconded by Elliott and carried to approve the minutes of July 17, 2018 as presented.

NOTICES RECEIVED: NDCCA Resolutions from 2014 to 2017, no action taken. A quarterly report from Leigh Gunkel, NDSU Family Nutrition Program Assistant was reviewed.

INDEMNITY BOND FOR LOST INSTRUMENT: On motion of Amb, seconded by Eblen and carried to approve the Indemnity Bond for Lost Instrument filed by Zee Medical for Auditor's Check #94175 dated 06-05-18 as check was lost in the mail.

CUSTODIAN: Jenni Rubash, Custodian discussed the Cenex propane contract, which had been tabled from the last meeting. After much discussion it was decided to keep the size propane tank we have now and remain on keep fill with Cenex. On motion of Amb, seconded by Eblen and carried to hire K. Petrowske Builders, LLC of Hillsboro for concrete work on the courthouse grounds totaling \$6,624.00. Rubash was instructed to talk to Ken Nesvig about contacting Bobbi Heppner-Olson, Architect about the problems with the heating and cooling systems installed in the south addition to the courthouse.

HILLSBORO AIRPORT BUDGET: Les Hurt presented the 2019 budget for the Hillsboro Airport and thanked the Board for their continued support. No action was taken.

SHERIFF: Steve Hunt, Sheriff and Tracey Buzick, ND Highway Patrol discussed the possibility of adding a Deputy for Truck Enforcement for weighing overloaded trucks. Due to the added costs involved by adding another Deputy, the County will continue relying on the ND State Highway Patrol for checking trucks.

TAX DIRECTOR: Kayla Knudson, Tax Director presented to the Board an Application for Abatement filed by Michael Anderson for a 5.32 Acre farmstead located in the N1/2 SE ¼ section 20 in Herberg Township. Anderson is filing the abatement under the "Farmers Home Exemption" claiming it is used by his farm laborer. Herberg Township Board had previously approved the exemption. Knudson informed the Commissioners that Charles Stock, Traill County States Attorney will be requesting an Attorney General's opinion on the Farm Labor Exemption. On motion of Eblen, seconded by Amb to approve the abatement as filed. After discussion on whether to wait for the Attorney General's opinion, the following roll call vote was taken for the motion: voting Aye: Commissioner Eblen, voting Nye: Commissioners Amb, Elliott & Young, Commissioner Nesvig, absent and not voting, abatement denied. Knudson explained the Vanguard line item presented in her 2019 budget request. This would implement electronic property cards for the County. No action was taken.

HIGHWAY DEPARTMENT: Corwyn Martin, Road Superintendent, Kevin Sondreal and Wayne Larson met with the Board and requested \$10,000.00 for dust control for a 2 mile stretch along Grand Forks #25, which is shared by Traill County. Grand Forks County previously approved the request. Martin explained he has budgeted for this project. On motion of Elliott, seconded by Eblen and carried to approve the request of \$10,000.00 for 2018 dust control. Martin informed the Board that Traill County's Load Pass is up and running. Martin will place notice in the paper. On motion of Amb, seconded by Eblen and carried to approve the Ditch Cleaning Permit filed by Lucas Sobolik along County Road #21 in Stavanger Township. Martin updated the Board on various projects. Clifford Elevator asked for permission to haul on County Road #1, between 80,000-105,500 pounds with the legal axel configuration. This request is only during the construction of the state intersection US18 & County Road 9 & 14. On motion of Amb, seconded by Elliott and carried to allow the additional weight request, only during the construction time.

TREASURER: Carla Swanson, Treasurer requested to transfer all funds from Wells Fargo Bank to Dakota Heritage Bank due to the transaction fees Wells Fargo will be charging Traill County starting on August 13, 2018. On motion of Amb, seconded by Elliott and carried to approve the transfer of funds.

HUMAN SERVICES: Kim Jacobson, Traill County Human Service Director presented to the Commission a Traill/Steele Joint Social Service Agreement. The two counties will work together to provide quality, efficient and cost-effective services to our citizens. The new district would be called Agassiz Valley Social Services District, with Traill County housing the district office. The Steele County Social Service Board approved the District's policies and contract at their regular meeting today (08-07-18). On motion of Elliott seconded by Amb to approve the merger between Traill and Steele County for the purpose of establishing a Social Service District, upon roll call vote those voting Aye: Commissioners Elliott, Eblen, Amb and Young. Commissioner Nesvig absent and not voting, the District was approved as presented.

The remainder of the meeting was spent on reviewing 2019 budget requests.
