The Traill County Commissioners came to order on November 8, 2018 at 8:00 a.m. with all members present. On motion of Eblen, seconded by Elliott and carried to approve the minutes of October 16th as presented.

COUNTY DEEDS: On motion of Elliott, seconded by Amb and carried to allow the Chairman and Auditor to sign a County Deed with Jay H. Burley for parcel #27-0009-07414-020 as property had gone back to the County during the tax foreclosure proceedings. On motion of Amb, seconded by Eblen and carried to allow the Chairman and Auditor to sign three County Deeds with Rodney Bjornstad for parcel #s 26-0004-06469-000, 26-0004-06468-000 and 26-0003-06243-000 as the properties had gone back to the County during the tax foreclosure proceedings.

RAFFLE PERMIT: On motion of Amb, seconded by Eblen and carried to approve a raffle permit filed by Central Valley Public School-TSA for the 2019 calendar year.

COUNTY APPAREL: Approved at the 10-16-18 meeting was the purchase of a shirt for each employee with the Traill County logo on the front, as long as the department does not overdraw their budget. Departments were questioning how much they can spend. On motion of Elliott, seconded by Amb and carried to approve a max of \$50.00 per employee to purchase apparel with the Traill County Logo.

COUNTY CEMETERY: Haugen informed the board that we need to look for someone to mow the county cemetery. This issue is tabled until further clarification from Charlie Stock, States Attorney on cemetery upkeep.

CORRESPONDENCE RECEIVED: Notice on the 69th ND County Road conference on 01-29-19, invite to the Veterans' Day Musical Tribute which will be held at Bruflat Lutheran Church, Portland 11-11-18 at 2:00, invite to the ND Water Convention & Irrigation Workshop on 12-04-18.

VICTIM WITNESS GRANT: Charlie Stock, States Attorney; Cherie Johnson, VW Coordinator and Jody Schill Deputy Clerk of District Court met with the board. Discussion was held on the Victim Witness Grant vs. the 2019 approved budget. Johnson explained the grants run from October 2018 and ends on September 2019. When submitting the quarterly reports for reimbursement, Johnson explained that the amount for salaries needs to coincide with what was submitted in the original grant; however we can add additional employees at any time. The amount submitted for salaries is \$9,600.00 and the amount approved in 2019 for salaries is \$9,652.00. On motion of Eblen, seconded by Amb and carried to allow the County Auditor to adjust the budget to reflect the approved grant.

HIGHWAY DEPARTMENT: Corwyn Martin updated the board on various road issues. Requested to have Charlie Stock, States Attorney look into the Mud on Road policy. Martin said that Belmont Park has been locked and he will barricade the driveway until further notice. On motion of Amb, seconded by Eblen and carried to allow Martin to sign the 2019 Load Pass Renewal contract. Road employees will be going to 8 hour days as on 11-12-18. Martin requested a special meeting to discuss budgets, meeting will be held on Thursday 11-15-18 at 11:00 a.m.

SOCIAL SERVICES: Kim Jacobson, Director presented an amended Agassiz Valley Social Services District agreement between Traill and Steele Counties. Steele County had approved the amended agreement on 11-06-18. Discussion was held on the 80/20 split of expenses and Jacobson explained that the population, formula payments and caseloads of both counties were taken into consideration when coming up with the split. On motion of Eblen, seconded by Amb and carried to approve the amended agreement as presented. On motion of Eblen, seconded by Amb and carried to allow the Chairman to sign a formal letter written to .Gov Domain Registration, requesting to assign the avaa-nd.gov second-level domain name for Traill County to be used for Agassiz Valley Social Service District.

HUMAN RESOURCES: Heather Hovey, Deputy Auditor discussed Traill County's drug policy. On motion of Elliott, seconded by Eblen and carried to allow drug testing of any Traill County employee that files a medical worker's compensation claim with the county. On motion of Amb, seconded by Eblen and carried to include the E911 Dispatchers in the random drug testing held throughout the year, as the Federal Government considers E911 Dispatchers "Safety Sensitive Employees" which is already in our current drug policy.
