SHERIFF: Steve Hunt, Sheriff and Matt Mutzenberger, Hillsboro City Auditor met informed the board that the Sheriff's vehicle, which the county had purchased from Hillsboro City for \$1.00, needs a new engine which has been estimated at \$7000.00. The Hillsboro City Council met and discussed the options of repairing the car or replacing and offered Traill County \$30,000 to purchase a new vehicle with the balance to Traill County of approximately \$10,000. After much discussion, on motion of Nesvig, seconded by Eblen and carried to purchase a new sheriff's car.

HIGHWAY: Corwyn Martin, Road Superintendent informed the board that the railroad crossing along county road 3 will be up for installation in 2020. The county share will be 10%, at this time no estimates are available from the ND DOT. On motion of Nesvig, seconded by Elliott and carried to allow Martin to advertise to purchase a chip spreader. Martin informed the board that in 2019 he will be looking to bid a skid steer also.
