INDEMNITY BOND ON LOST INSTRUMENT: On motion of Eblen, seconded by Young and carried to approve the Indemnity Bond for lost check #93881 in the amount of \$22.89.

TAX DIRECTOR: Kayla Knudson, Tax Director presented an application for property tax incentive. On motion of Elliott, seconded by Young and carried to approve the application filed by Clifford Farmers Coop Elevator for a 5 year, 100% exemption for a new fertilizer plant located in SW ½ 21-144-53 in Galesburg Township.

HIGHWAY DEPARTMENT: Corwyn Martin, Road Superintendent, Charlie Stock, States Attorney and Matt Lange, KLJ met with the Board. On motion of Eblen, seconded by Nesvig and carried to approve the application for a new approach to access a new home located along highway 10 in Buxton Township, section 36. Set a meeting date of July 16, 2019 at 8:10 a.m. to meet with representatives of Taft Elevator to discuss the approach that runs along County Road 13. Martin discussed the repair issues/costs of upwards of \$6,000.00 to fix the tar kettle. On motion of Eblen, seconded by Young and carried to allow Martin to purchase a used tar kettle from Swanson Equipment in the amount of \$12,000 with trade-in. Discussion on Bridge 421 located in Stavanger Township along Highway 81 south of Central Valley School.
