The Traill County Commissioners came to order on August 20, 2019 at 8:00 a.m. with all members present. On motion of Elliott, seconded by Nesvig and carried to approve the minutes of August 6, 2019 as presented.

COUNTY PARK: Glenda Haugen, Auditor updated the Commission with park expenses totaling \$ 4,207.64 and collections totaling \$ 2,970.00 as of 08-19-19. Wayne Berg, Park Curator presented an additional \$730.00 in collections and informed the Commissioners they need a new weed trimmer. Commissioner Nesvig will purchase a weed trimmer. On motion of Young, seconded by Nesvig and carried to close the County Park for the season on September 30, 2019.

EMPLOYEE BENEFITS: Judy Ingvalson, Representative of New York Life Insurance asked permission to present information to Traill County employees. Premiums are 100% paid by the employees with a minimum of 10 employees needed to commit to the new company. On motion of Young, seconded by Nesvig and carried to allow Ingvalson to present the information to county employees. Kim Jacobson, Agassiz Valley Social Service Director discussed the Retirement Policy for employees. On motion of Eblen, seconded by Young and carried to allow Jacobson to purchase a gift card in lieu of a retirement party for a retiring employee.

HIGHWAY DEPARTMENT: Corwyn Martin, Road Superintendent met with the Board. On motion of Eblen, seconded by Young and carried to approve the Encroachment Permit filed by Xcel Energy to install underground cable in Buxton Township, along sections 25 and 36. On motion of Eblen, seconded by Nesvig and carried to approve three ditch cleaning permit filed by Les Amb & Family as follows: (1) along county road 19, sections 7, 9, 10, 15 & 17 in Viking Township (2) along county road 9, section 26 and (3) along county road 13 in section 16. Martin informed the board of an insurance claim for damage done to a vehicle on county road 4. Lee Erickson is working on the claim. On motion of Young, seconded by Elliott and carried to approve the Right-Of-Way Encroachment filed by SRS Commodities to add a culvert and fill in ditch along County Road #14 in the NE1/4 of section 31 in Lindaas Township. On motion of Nesvig, seconded by Eblen and carried to set gravel stockpile bids for 09-17-19 at 8:05 a.m. Martin informed the Board he will be closing out the 2013 Disaster FEMA funds.

COURTHOUSE PARKING LOT: Jenni Rubash, Head Custodian and Matt Lange, KLJ gave updates for the expansion of the parking lot. After reviewing 4 alternatives, on motion of Nesvig, seconded by Elliott and carried to allow KLJ to proceed with a plan for option D, increasing the lot to accommodate 51 parking spaces. On motion of Eblen, seconded by Young and carried to allow the Chairman to sign the Acceptance of Proposal with Precision Electric, Mayville to install lights and outlets in the parking lot.

DAKOTA NATURAL GAS: Charlie Stock, States Attorney reviewed a request of minimum use. On motion of Elliott, seconded by Young and carried to have Stock draft a letter to Dakota Natural Gas concerning the Minimum Use Agreement for Traill County and ask Dakota Natural Gas to come to the next meeting.

MUD ON ROAD: Charlie Stock, States Attorney presented a revised Mud on Road policy. On motion of Nesvig, seconded by Elliott and carried to approve the revised policy as presented. Martin will give copies to all Townships and the Sheriff's Department.

STATES ATTORNEY: Charlie Stock, States Attorney discussed a letter from Kyle Hart, Attorney for R.J. Zavoral & Sons concerning the \$24,000.00 liquidated damages assessed to Zavoral for completing project #TC CNOC-4919(057) past the contract deadline. A committee of Les Amb, Tom Eblen, Corwyn Martin, Matt Lange and Charlie Stock will gather and discuss the situation and meet with the full board at a future meeting. The final payment to R. J. Zavoral & Sons will be approved as of today. On motion of Elliott, seconded by Nesvig and carried to join the ND State's Opioid Lawsuit.
