SPECIAL REQUEST: On motion of Amb, seconded by Young and carried to allow classmates/friends to plant a tree on the courthouse lawn in memory of Edna Riendeau, an employee of Agassiz Valley Human Services that passed away. The group will be instructed to contact Jenni Rubash to determine where and what kind of tree/shrub to plant.

HORSE PULL: On motion of Amb, seconded by Young and carried to allow Paul Geray to host a horse pull on county property.

SIGNATURES NEEDED: On motion of Young, seconded by Amb and carried to allow Chairman Eblen to review and sign all bills presented for payment and any questionable bills will be reported back to the full commission.

SPECIAL COVID-19 MEETINGS: Future meetings of the Unified Command Team, discussing COVID-19 updates will be added to the regular meeting agenda for the Commissioners and will be held once a month, or sooner as needed. The next COVID-19 updates will be on Tuesday, June 16th.
