The Traill County Board of Commissioners came to order on May 19, 2015 at 8:00 a.m. with all members present.

On motion of Amb, seconded by Larson and carried to approve the minutes of May 5, 2105 as presented.

Cory Martin, Road Superintendent met with the commission on various matters. He gave the commission a copy of a listing of all bridges within the county. He asked permission to have KLJ look at two bridges, Bridge #106 and Bridge #120 that are currently on the code 3 bridge listing. The commission granted the request. Martin also stated that he had met with NDDOT and also BNSF for crossing arms along CR #3 and CR #81. Martin also asked permission to advertise to replace an employee. The commission granted the request. Martin informed the commission that himself and Kris Bakkegard and Matt Lange, KLJ will be looking at three box culverts on CR #21 that are currently in need of signage because of being rough. Jenni Rubash, Custodian presented bid tabulations for the reroofing project. On motion of Amb, seconded by Elliott and carried to accept the bid of A & R Roofing Company, Fargo for a total cost of \$62,260.00. She gave an update on the doors that are going to be installed. She asked permission to cut down the tree right south of the courthouse and by the sidewalk. Commissioner Elliott will look at the tree after the meeting.

Barb Zerface, Tax Director met with the commission to present them with two properties for the commission to approve as omitted property. On motion of Elliott, seconded by Nesvig and carried to put a residential structure assessment of \$100,000 on a 1 ac tract located in SW½ of Section 7 in Eldorado Township owned by John R Jr. and Melody A Osgood and to also put a residential structure assessment of \$100,000 on a 8.13 Ac Tract S of Goose River in SW¼ in Section 21 of Caledonia Township owned by Jeremy & Sara Jennen. She also presented an abatement filed by David & Paul Mueller. On motion of Larson, seconded Nesvig and carried to approve the abatement as presented and approved by the Ervin Township Board to remove the residential structure assessment for tax years 2012, 2013 and 2014 on the property located on the S 865' of E 2325' of SE¼ in Section 17 of Ervin Township.

The commission gave permission to Rebecca Braaten, County Auditor to check with Melissa Beach, Traill County Economic Development Director on a new website for the county.
