The Traill County Commissioners came to order in regular session on Tuesday, May 5, 2020 at 8:00 a.m. with all members present via conference call. Also, present on-line: States Attorney Charlie Stock, TC EDC Director Jim Murphy, TC Extension Agent Jill Lagein, TC Road Superintendent Corwyn Martin and KLJ Engineer Matt Lange. On motion of Amb, seconded by Elliott and carried to approve the regular minutes of April 21, 2020. On motion of Amb, seconded by Young and carried to approve the special meeting minutes of April 22nd, April 28th and April 29, 2020.

COUNTY DEED: On motion of Young, seconded by Nesvig and carried to allow the County Auditor and Chairman to sign a County Deed with Robert Petrie for parcels #04-0000-00585-000, 04-0000-00585-010 and 04-0000-00586-000.

DAKOTA NATURAL GAS: On behalf of the County Commissioners, Murphy drafted and read a letter of support for the Dakota Natural Gas Company. On motion of Young, seconded by Nesvig and carried to approve the letter and allow Chairman Eblen to sign.

EXTENSION SERVICE: The Commissioners welcomed Jill Lagein as our new NDSU Extension Service Agent.

DRAIN 72 & 79: Stock informed the Board that he had communicated with Sean Fredricks, Water Board Attorney and the County's offer to make 3 payments for drain 72 and 79. No word from the Water Board has been received.

RIVERWALK-HILLSBORO: Lange discussed the new Riverwalk addition to Hillsboro City. The County's concerns about access points along County Road 11 has not been addressed. Stock also reviewed the plans noticing only one access point in and out of the property. Martin informed the Board that because the property is along a county road, they must ask for approval to add any access points in the future. Commissioners asked Lange to contact the City to discuss the new addition and bring back to the next meeting.

HIGHWAY DEPARTMENT: On motion of Amb, seconded by Nesvig and carried to allow the Highway Department to clean a ditch located along County Road 21 at the County's expense because of work previous completed in that area by the Highway Department. A request from Jeremy Brandt requested the county to install a culvert under his driveway. On motion of Nesvig, seconded by Amb and carried to allow the county to install an 18" culvert along County Road 21 as this is county right-a-way. On motion of Amb, seconded by Young and carried to allow the Chairman and Auditor sign a Right-A-Way Encroachment & Crossing permit filled by Haugen Farms to lower a culvert along CR 19 in section 18, Viking Township. Lange presented the following quotes to repair Bridge 361 in Viking Township: Wasnick \$57,850.00, IVI \$48,469.00 and Swingen \$27,461.00. Swingen's quote was lower because they have other work in the area. On motion of Amb, seconded by Young and carried to approve the Swingen quote. Martin discussed a new product from Subsurface Drains that will allow an existing culvert to be "lined" instead of replaced. On motion of Amb, seconded by Elliott and carried to allow Martin to hire Subsurface Drains to install a liner in the culvert along County Road 9 and County Road 16 under his maintenance program. Martin requested approval to install Razor Tracking in his equipment at a cost of \$6000.00 for installation and \$3000.00 yearly maintenance fees. The tracking will record mileage and work being done. Martin was asked to get more information and bring back to the next meeting.

SUMMER HOURS: Commissioners discussed the summer hours that normally run from Memorial Day to Labor Day. A decision will be made at the next meeting as to when the summer hours will begin.

AUDITOR: Glenda Haugen discussed having an audit done yearly or every two years. The cost savings to the county is close to \$8000.00 for having a 2-year audit. The Commissioners will decide once the final report and billing is received from the ND State Auditor's for the 2018 & 2019 audit that was just completed. Election voting numbers are up compared to the previous Presidential Election of June 2016 which had 1870 voters. As of today, we have 1,908 voters that have requested ballots for the June election.

SIGNATURES NEEDED: On motion of Amb, seconded by Young and carried to allow Chairman Eblen to review and sign all bills presented for payment and any questionable bills will be reports back to the full commission.

STATE FUNDING/PRAIRIE DOG: Discussed the state funding shortfall expected. More information will be coming from the State to use for budgeting purposes. Lange will send out a link to the state website. HUMAN SERVICES: Received the monthly report the Agassiz Valley Human Service Zone.
