The Traill County Board of Commissioners came to order on November 17, 2015 at 8:00 a.m. with all members present excepting Commissioner Amb.

On motion of Nesvig, seconded by Elliott and carried to approve the minutes of November 3, 2015 as presented.

On motion of Nesvig, seconded by Larson and carried to approve a raffle permit for Central Valley Dollar for Scholars.

On motion of Elliott, seconded by Nesvig and carried to set the fuel bids for December 15, 2015 at 8:15 a.m.

A letter was received from Stuart Larson, States Attorney requesting the appointment of Lynn Slatthaug Moen and Scott Brand, both of Budvik Law Office as assistant Traill County State's Attorney effective immediately. On motion of Elliott, seconded by Nesvig and carried to grant the request.

Commissioner Larson discussed the proposed sheriff department remodel with the commission. Larson stated that he would like to see the project move forward saying that the projected cost has increased since the last time the county had looked at it. After discussing the matter further the commission will wait for Sheriff Hunt to returns to work to get his input on the project.

Tony Ernst, Deputy Sheriff and Paulette Bowersox, Clerk of District Court met with the commission concerning the county developing a weapons policy within the county. On motion of Larson, seconded by Nesvig and carried to approve the policy as it was presented.

Alyssa Scheve, County Agent met with the commission concerning a Large-Scale UAS Data Collection, Processing and Management for Field Crop Management. Scheve turned the presentation over to John Nowatzki, Agricultural Machine Systems Specialist to explain the project and how it will work. Terry Sandbo, UAS Sector Senior Manager of the Grand Forks Region Economic Development explained how it came that the area of Traill and Steele County were chosen for this project. Yuval Chaplin, Director of Major Campaigns, Elbit Systems of America explained how his company will be involved in this project to the commission. Scheve informed the commission that there will be a public hearing on this project on Thursday, November 19, 2015 starting at 1:00 p.m. in the community room of the courthouse.

On motion of Nesvig, seconded by Elliott and carried to allow the bids for an Excavator to be opened from General Equipment, Fargo; RDO, Grand Forks; ASC, Fargo and Butler Machinery, Fargo. On motion of Larson, seconded by Nesvig and carried to table any decision on this matter until the next meeting.

Cory Martin, Road Superintendent met with the commission on various matters. He requested that Steve Stabnow and Jay Showers both considered Operator II at the current time to be moved up to the Operator III status effective January 1, 2015. On motion of Nesvig, seconded by Elliott to allow the request but that Martin make sure that he has the money in his budget to account for it. Martin presented a Flowage Easement Agreement presented by Joseph F Larson II. The

commission requested that this be given to Stuart Larson, States Attorney to look over and return to the next meeting for a final decision on this. He also addressed the letter received from Steele County in which they requested that the county road crew put in a bid to do 14 miles of chip sealing on their CR #5 to be completed in 2016. After discussing the matter the commission decided to decline the request. Martin also received a call from the Norman County Road Department stating that the approach apron on the Shelley Bridge have settled and work needs to be done on this and would like to see it fixed yet this year. The commission said to proceed with the project if the cost is not too high. Martin also presented a ditch cleaning permit filed by Michael Waldner for west side ditch along CR #14 in Section 6 of Greenfield Township. Martin asked that this request be denied as this ditch will be cleaned next year by county forces. On motion of Elliott, seconded by Larson and carried to deny the request as presented and as requested by Martin.
