The Traill County Commissioners met in regular session on Tuesday, July 7, 2020 at 8:00 a.m. with all members present. On motion of Elliott, seconded by Young and carried to approve the minutes of 06-16-2020 as presented. On motion of Nesvig, seconded by Elliott and carried to approve the special minutes of 06-23-20 as presented.

PUBLIC BUDGET HEARING: On motion of Young, seconded by Nesvig and carried to set the 2021 Public Budget Hearing for Wednesday, September 9, 2020 at 6:00 PM.

STIMULUS MONEY: Casey Buchmann, Democratic-NPL running for ND Public Service Commission introduced himself to the Commission. Buchmann talked about the 1.25-billion-dollar stimulus money and his concerns about how the State Department is spending the money. Buchmann suggested calling our State Representatives to discuss how the stimulus money is being spent.

HIGHWAY DEPARTMENT: Corwyn Martin, Road Superintendent gave updates for his department. On motion of Amb, seconded by Nesvig and carried to allow the Chairman and Auditor to sign a County Road/Right-O-Way Encroachment for Jack & Joey Camrud for a culvert along Highway 81 in section 31 in Stavanger Township. On motion of Elliott, seconded by Amb and carried to allow the Chairman to sign a Drive Permit filed by American Crystal Sugar Company for access off County Road 13, east of the intersection of US Highway 81 and TC Road 13. On motion of Amb, seconded by Young to allow the Chairman to sign a ditch cleaning permit filed by Ken Grinde along County Road #11, in section 21 of Roseville Township. Discussion was held on the closure of the low water crossing along the east/west road by Harley Scholl's farmstead. The road had been undermined and needed to be closed. The Commissioners asked Martin and KLJ, Engineers to take a look at the costs to repair and bring back to a future meeting. Commissioners gave Martin permission to approach Hillsboro City and ask for a 50/50 split to have patches on the street in front of the highway shop. Martin and Young met with land owners concerning the silt along County Road #25. Matt Lange, KLJ and Martin will check out the issue and report back to the next meeting. Other issues discussed, chip sealing on County Road 13, holes in highway north of Portland is a concern. Martin met with an independent insurance adjuster on the Brandon Schreiner insurance claim. All reports have been sent to the State Department.

KLJ, ENGINEER: Matt Lange, Project Manager discussed the work completed by Zavoral on County Road #11. There is a few areas that need to be fixed. On motion of Young, seconded by Amb and carried to approve the pay estimate #1 submitted by R. J. Zavoral for work done on County Road #13 in the amount of \$35,282.02. Lange presented the two bids received from the June 29, 2020 bid opening for Bridge 366. Bids received were from Industrial Builders in the amount of \$464,690.60 and Burski Excavating in the amount of \$277,378.60. The engineers estimate was \$308,000.00. Lange informed the board he had checked on references and work previously completed by Burski Excavating, as this is a company Traill County has never used. On motion of Amb, seconded by Young and carried to award the bid to Burski Excavating with work to be completed at the end of October. Lange presented Exhibit A-Scope of Services for Mitigation Monitoring on the Caledonia Bridge. This monitoring is a requirement for up to 5 years following the completed work. On motion of Elliott, seconded by Nesvig and carried to allow the Chairman and Auditor to sign the agreement in the amount of \$3,900.00 with a completion date of 09-01-20. Lange informed the Board that Kris Bakkegard has resigned with KLJ to take an engineer's position on the Fargo-Moorhead Diversion Project. Lange introduced Cassie McNames, Senior Engineer with KLJ who will be overseeing projects with Lange.

COUNTY DEED: On motion of Nesvig, seconded by Elliott and carried to allow the Chairman and Auditor to sign a County Deed with the City of Hillsboro for the N ½ of Lot 1, Block 1 Sorlies Addition, parcel #26-0030-0001-000 as property had gone back to the County for non-payment of taxes.

E911 SURCHARGE: Discussed the possibility of increasing the E911 landline and cell phone line surcharge from \$1.00 to \$1.50 to help with purchasing new equipment. On motion of Elliott, seconded by Young and carried to place the E911 surcharge on the November ballot.

SHERIFF: Steve Hunt, Sheriff informed the board his razor tracking devices in each vehicle needs to have the hardware upgraded. Commissioners approved the upgrade as Hunt has the money in his budget. Hunt informed the

board he will be meeting with Ben Gates, Assistant DES, Corwyn Martin, Road Superintendent and Matt Lange, KLJ to discuss three areas in the county where the riverbanks have been compromised. Two homes are very close to the areas in question. The group will be discussing ways to help with the areas, possible FEMA buyouts, Mitigation to stop the erosion and/or moving the homes out of the flood zone. Hunt was instructed to contact Lake Agassiz as they were very helpful in the 1997 flood buyouts.

RETIREMENT: Dave Sather presented his letter of resignation effective May 5, 2021. Sather asked the Commission to allow Martin to hire his replacement early so proper training can be completed. Sather also discussed the possibility of getting a catwalk to help with installing signs. Commissioner Elliott holds the Road Department portfolio and will meet with Martin to discuss the issue. The Commissioners thanked Sather for his 39 years of service.

HANDOUTS: Received a copy of the Worksite Wellness Program Report for the year July 2019-June 2020. No action needed.

COVID-19: Members of the Safety Planning Team: Kim Jacobson, Stacy Smelden and Jenni Rubash, along with Chris McInnes and Kelly Radebaugh, attending on behalf of Brenda Stallman, presented the COVID-19 Workplace Safety Committee Scope of Study Report. Areas of discussion included: (1) Accessibility, Security and Building Safety. Jenni Rubash presented a list of items throughout the courthouse that could be renovated to be "touchless" such as drinking fountains, bathroom faucets, soap dispensers and bathroom doors. Also discussed air purifiers for each office. On motion of Elliott, seconded by Young and carried to allow Commissioner Amb and Rubash to review the list and report back to the next meeting on suggested items for replacement. (2) Environmental Assessment. Kelly Radebaugh discussed the meeting held with Loffler Companies, installing screening kiosks and card access systems. More information will be available at a later date. The following policies were approved as supplements to our personnel policies as COVID-19 related addendums:

COVID POSITIVE EMPLOYEE POLICY: On motion of Elliott, seconded by Nesvig and carried to approve the Traill County Covid Positive Employee Infection Control Plan. This plan explains how the Covid virus spreads, symptoms, what to do if a co-worker shows signs of symptoms, who to notify along with Education & Training to help decrease the spread of COVID-19.

COVID WORKPLACE CHECKLIST: On motion of Nesvig, seconded by Elliott and carried to approve the Traill County Government "New Normal" Workplace Checklist Policy. This checklist gives the offices and individuals protocols and explains the expectations for all involved.
