The Traill County Commissioners came to order on August 3, 2021, with all members present. The agenda was changed to allow a phone call with States Attorney Stock at 8:45 a.m. and for Commissioner Young to discuss AVHSZ information. On motion of Eblen, seconded by Amb and carried to approve the updated agenda. On motion of Young, seconded by Nesvig and carried to approve the minutes of July 20, 2021 as corrected. On motion of Nesvig, seconded by Eblen and carried to approve the minutes of the County Park Board, dated July 20, 2021. On motion of Young, seconded by Eblen and carried to approve the special meeting minutes of July 26, 2021.

AVHSZ: On motion of Amb, seconded by Nesvig and carried to allow the Auditor to transfer old year taxes collected for Human Services-original fund to the Human Services-Indirect Fund.

CAPITAL PROJECTS: On motion of Amb, seconded by Nesvig to rescind the motion to transfer funds to various capital projects, which motion was made on July 20, 2021. On motion of Young, seconded by Amb and carried to allow the Auditor to establish separate Capital Project Funds for the General Buildings, Road Buildings, Road Equipment and Road/Bridge repairs.

HONG DRAIN IMPROVEMENT #81: On motion of Nesvig, seconded by Young and carried to allow the Chairman and Vice-Chairman to sign a ballot and vote yes for the proposed Hong Drain Improvement project #81.

AVHSZ: Received AVHSZ June financials & July board minutes, no action needed. Commissioner Young informed the board that Kim Jacobson, AVHSZ Director has been hired on a part-time basis to help with Cass County Social Service Zone until a new director can be hired, approximately 2 months.

TRAILL COUNTY BENEFITS: Reviewed a ND Statewide benefit comparison spreadsheet on employee benefits. No action taken at this time.

HIGHWAY DEPARTMENT: Corwyn Martin, Road Superintendent and Matt Lang, KLJ gave updates to the board on various projects. On motion of Eblen, seconded by Amb and carried to approve a Right-of-way encroachment permit filed by Ross Johnson, along County Road #21 in the SW ¼ of section 34 in Buxton Township. Martin was granted approval to gather prices to replace the Mayville Shop and bring back to a future meeting. On motion of Amb, seconded by Nesvig and carried to allow Martin to advertise bids for a new motor grader. On motion of Amb, seconded by Nesvig and carried to approve the request from Lang to finalize the wetland monitoring on the Caledonia Bridge. There are funds available from the 2020 to cover the expense. Lange will look into the ability to create wetland sites in Traill County for future projects. NDDOT updated Traill County's Federal Funds for 2022 which Lange and Martin will set up a meeting to review. On motion of Nesvig, seconded by Young and carried to approve a request of \$15,000.00 from Traill County for dust control along Eagle Avenue, Reynolds pending funds available in the Highway Budget.

TAX DIRECTOR: Kayla Knudson, Tax Director informed the board her office will be closed September 21st and 22nd with the Recorders office taking calls.

RECORDER: Marlene Eblen, Recorder informed the board her office will be closed August 17th thru 20th with the Tax Director's office taking calls.

DES: Steve Hunt, Sheriff/DES Director and Ben Gates, Assistant DES presented letter of approval for the Statewide Interoperability Radio Network (SIRN) project. Total cost to the project will be \$420,788.00, which will be completed in stages with an end date in 2023. On motion of Amb, seconded by Eblen and carried to allow the Chairman to sign the letter to proceed with the project. A request to use current SIRN funds to purchase the Fire Department radios, with reimbursement from the State and Fire Departments expected to be received by the end of 2021. On motion of Young, seconded by Amb and carried to allow the purchase of Fire Department radios.

WELLS FARGO BANK: Charlie Stock, States Attorney met via phone call concerning the future sale of the Wells Fargo Bank building in Hillsboro. Stock will take the lead in negotiations with Wells Fargo on the county's behalf. Currently

we lease seven offices in the building. The building will be sold to the highest bidder starting September 23, 2021. Traill County's lease with Wells Fargo Bank ends on October 31, 2021, however, Kim Jacobson, AVHSZ Director requested a six-month extension of the lease, which we are waiting for an approval from Wells Fargo. Discussion was held on funds available to the county for purchasing the building. The County can take out a Certificate of Indebtedness, at a max of \$500,000.00 payable up to 5 years. On motion of Young, seconded by Nesvig and carried to place additional mills into the Capital Project Levy to bring the levy up to the 10-mill max as allowed by law. The county is waiting on more information from Wells Fargo before a decision is made with submitting a bid for the building.

2022 BUDGETS: On motion of Eblen, seconded by Nesvig and carried to set the 2022 Estimated County & State Tax Levy at 124.18 total Mills, totaling \$7,570,813.84. The County budget hearing is set for Wednesday, September 8th at 6:30 p.m. in the Traill County Commissioner's office.

COUNTY BENEFITS: Commissioners reviewed Traill County employee benefits as compared to other counties within the State. Traill County ranks well below average when offering benefits to their employees. Commissioners will review the benefit package at a later date.
