The Traill County Commissioners came to order on Tuesday, December 21, 2021, at 8:00 a.m. with the following members present: Commissioners Eblen, Elliott, Nesvig and Young. Commissioner Amb attended via Webex. Addition to the agenda: Commissioner Elliott added pay adjustment. On motion of Eblen, seconded by Young and carried to approve the amended agenda. On motion of Nesvig, seconded by Young and carried to approve the minutes of December 7, 2021.

AMBULANCE: On motion of Young, seconded by Amb and carried to allow the Chairman to sign the 2022 Service Contract with West Traill Ambulance Service.

SOILS: The ND State Tax Commissioner notified Traill County, In accordance with ND Century code 57-02-27.2, has conducted a review of the agricultural land valuation procedures in Traill County and have found Traill County to be in compliance of the soil survey method of valuation.

REMARK TECHNOLOGIES: On motion of Eblen, seconded by Nesvig and carried to allow the Chairman to sign the 2022 Technology Managed Services Contract with Remark, and to pay the contract in one lump sum in January 2022.

CORRESPONDENCE: Received notice of webinar available to Commissioners and Department Heads to discuss the risk of fraud for ARPA and Cares Act Funding. Webinar is scheduled for January 6, 2022.

HIGHWAY DEPARTMENT: Corwyn Martin, Road Superintendent met in person along with Matt Lange, KLJ Engineer meeting via Webex. On motion of Amb, seconded by Eblen and carried to award Bridge #92 bids to Jensen Brother's Construction Company of Fargo. Lange will notify the company and prepare a contract. Lange discussed the possibility of funding that may be available thru the ARPA Funds the County received. New funding needs to pass Congress before the ARPA Funds can be used for infrastructure, more information to come later.

WATER RESOURCE: Jason Siegert, TCWR Director and Jessica Spaeth, TCWR Secretary/Treasurer met with the board. Discussion was held on the assessments placed on the townships and county for the Elm River Water Shed for 2022. The Water Resource Board has "rescinded" the assessment to be the same as last year and will draft a letter to request abatements of the additional assessment.

SHERIFF DEPARTMENT: Joel Walsvik of Sebeka MN, Sheriff Steve Hunt, States Attorney Charlie Stock and Deputy Sheriff Thomas Burr met with the board. Mr. Walsvik has concerns with the Sheriff's Department taking a photo of his driver's license when he was stopped along the road changing a flat tire and did nothing wrong. Walsvik questioned whether a law exists that allows your driver's license to be photographed when you have not committed a crime and questioned the response time for his open records request, which he felt should be answered within 10 days. States Attorney, Charlie Stock informed Walsvik that the County will respond to his open records request within the next week.

AGASSIZ VALLEY HUMAN SERVICE ZONE: Kim Jacobson, AVHSZ Director informed the Commissioners that her AVHSZ Board reviewed the 2021 indirect fund balance including the County Wide Cost Allocation Plan and determined a reimbursement to Traill County in the amount of \$46,156.75 and to Steele County \$2,583.00 has been processed. On motion of Young, seconded by Eblen and carried to appoint Doris Vigen to the AVHSZ Board for a 3-year term. Steele County Board members will be filled by the Steele County Commission. Jacobson informed the board she has a "signed" lease with Wells Fargo and the lease will convert over to Dakota Heritage Bank once they take over.

RISK MANAGEMENT: Heather Hovey, Chief Deputy Auditor met with the Board over payroll issues. On motion of Eblen, seconded by Nesvig and carried to place in our Policy Manual #402 a statement that requires all employees to receive their Statement Of Earnings by email or it must be picked up, in person, in the Auditor's Office. Hovey informed the Board she is researching a new payroll system.

OPIOID SETTLEMENT: Charlie Stock, States Attorney discussed the upcoming Opioid Settlement. On motion of Amb, seconded by Young and carried to allow Stock to enter into the settlement and sign the needed documents.

PAYROLL ADJUSTMENT: On motion of Elliott, seconded by Nesvig and carried to adjust the 2022 salary of Deputy Treasurer Tiffany Ambuehl to \$42,000.00.

ARPA COMMITTEE: Ben Gates, Chairman of the ARPA Committee presented the Traill County American Rescue Plan Act Notice of Funding Opportunity and Application Guidance, compiled by the ARPA Committee. On motion of Eblen, seconded by Young and carried to approve the Guidance forms as presented. The ARPA Committee will place ads in the papers and send out the application to business in the County.
