SHERIFF: Steve Hunt, Sheriff presented a letter of resignation from Tami Moore, E911 Dispatcher. On motion of Young, seconded by Amb and carried to accept the resignation.

BELMONT PARK: Kayla Knudson, Tax Director presented an email from Chris Jordheim, PLS Land Surveyor concerning the Belmont Park property. Commissioners decided earlier not to financially support a survey as the property does not belong to Traill County. Mr. Jordheim stated his company will complete a survey at no cost to the county. CUSTODIAN: Jenni Rubash, Head Custodian requested permission to pour cement slabs for under the garbage container and on the south side of the parking lot by the Sheriff's entrance at a cost not to exceed \$9,240.00. Rubash informed the board, the boilers have been tested and she will check with the engineers about removing the diesel tanks.

ELM & GOOSE RIVER SNAGGING AND CLEARING HEARING: Members of the TC Water Resource Board attending: Jason Lovas, Andy Neset, Joel Halvorson, Gary Thompson, Jessica Spaeth and Jason Siegert along with Nate Troren, Moore Engineer presented resolutions and a request to approve the Elm & Goose River Snagging and Clearing project for the 2022 tax statements. Siegert informed the board the State Water Commission has approved a 50/50 cost share for this project, and they should look at the project as maintenance for the county infrastructure. The Water Board has had several landowners contact them that are in favor of the project. Commissioners Eblen and Young have had landowners contact them and say they are not in favor of the project. Auditor Haugen read a letter received from Roger Anderson concerning the removal of trees on his property. Commissioners asked the Water Board to come back at a future meeting for further discussion.
