The Traill County Commissioners came to order on July 18, 2017 at 8:00 a.m. with all members present.

MINUTES: On motion of Eblen, seconded by Young and carried to approve the minutes of July 5, 2017 as presented. On motion of Elliott, seconded by Eblen and carried to approve the 2017 Board of Equalization minutes as printed on page 571 in Commissioner's minute book, motion carried.

CORRESPONDENCE: Received a letter of thanks from the President & COO of Energy Transfer concerning Traill County's involvement in the Dakota Access Pipeline protest. Commissioners received the 6 month financial reports for county budgets.

BRIDGE LOAN: On motion of Eblen, seconded by Young and carried to allow the County Auditor to send letters to various banks in the county relative to borrowing Certificates of Indebtedness for a Bridge Loan in the amount of \$200,000.00.

ECONOMIC DEVLEOPMENT: Melissa Beach, ECD Director presented the board with her 2016 Annual Report.

TREASURER: Connie Weber, Treasurer presented the unclaimed property report. On motion of Young, seconded by Amb and carried, to approve the list of checks, 1 year or older, to be sent to ND State as Unclaimed Property in accordance with NDCC.

Commissioner Elliott introduced the following resolution and moved its adoption which motion was seconded by Commissioner Amb:

BE IT RESOLVED by the Board of County Commissioners that banks in the county be designated depositories of public funds in the custody of the County Treasurer and in an amount not to exceed FDIC Certificates as follows, to wit: Wells Fargo-Hillsboro; Goose River Bank, Hillsboro, Mayville & Hatton; Aspire-Hatton; First & Farmers Bank, Portland & Mayville; First State Bank, Buxton; Dakota Heritage Bank-Hunter, Galesburg Branch & Hillsboro Branch (for such amounts as the county may find necessary).

BE IT FURTHER RESOLVED that pledges as assets in the county \$3,718,252 Wells Fargo: \$755,000 Goose River Bank, Hillsboro, Mayville & Hatton: \$930,000 Aspire: \$11,655,350 First & Farmers Bank: \$7,600,000 First State Bank: \$355,000 Dakota Heritage Bank-Hunter Galesburg Branch & Hillsboro Branch: are hereby approved for additional deposits by the County Treasurer in excess of FDIC Certificates \$250,000 as of June 30, 2017.

On roll call vote, the following members voted aye for the adoption of the foregoing resolution: Commissioners Young, Elliott, Eblen, Nesvig and Amb. The resolution was declared adopted.

HIGHWAY: Corwyn Martin, Road Superintendent gave updates on various road issues. Martin will be getting quotes for an 8 x 8 box culvert for Bridge 111.

UND PROPERTY: UND Wildlife Ecology Assistant Professor Jay Boulanger, PH.D. expressed interest on behalf UND to partner with Traill County in establishing a Wildlife Management Area located in Section 18 of Ervin Township. UND owns land surrounding property owned by Traill County. Commissioners are interested in the proposal but will contact legal counsel to discuss any liability issues with the project and will contact Professor Boulanger to return to a future board meeting.

STORM 07-11-17: Sheriff Steve Hunt, Custodian Jenni Rubash, County Agent Alyssa Scheve and 4-H Youth Development Agent Rachel Hiam discussed storm damages. ND Insurance Reserve Fund representative will be at the courthouse on Wednesday, July 19th to assess the damage. Areas of concern are as follows: located on courthouse property: (1) communications tower (2) roof on garage/generator building (3) heating/cooling units on roof of Sheriff's building (4) Lincoln statute and (4) several trees. Located on highway department property: (1) 4-H Quonset building. Hillsboro City declared an Emergency Declaration due to this storm. Charlie Stock, St. Attorney will be contacted to draft a Declaration for Traill County and present the Declaration at the next meeting allowing the County to access Emergency Funds for the repairs not covered by insurance.

EMPLOYEE POLICY ISSUES: Charlie Stock, States Attorney was present via phone call. Discussion was held on establishing an Employee Policy Committee. Committee would consist of States Attorney, Sheriff, Highway Superintendent, Auditor and Risk Manager. Commissioners were in favor of the committee. Discussion on final paycheck for Deputy Sheriff Steinhause. Commissioners instructed Stock to draft a letter to Steinhause notifying him the county will pay him an additional \$226.44 in vacation and \$14.69 sick leave payout, less applicable payroll taxes, however no action was taken on the Holiday issue in question. Once Steinhause signs off on acceptance of the additional pay, a payroll check will be issued.

CUSTODIAN: Jenni Rubash presented a contract from Farmers Union Oil, Portland for rental of the LP tank for the Sheriff's department. Auditor will contact Farmers Union Oil and inquire about purchasing the tank instead of leasing and bring to the next meeting.
