The Traill County Commissioners came to order on November 21, 2017 at 8:00 a.m. with all members present. MINUTES: On motion of Amb, seconded by Eblen and carried to approve the minutes of 11-07-17 as presented.

ELECTIONS: On motion of Young, seconded by Eblen and carried to set the 2018 Primary and General Election Precincts.

EXTENSION OFFICE: Glenda Haugen gave an update on the video conference concerning upcoming payments to NDSU for salary reimbursement for the County Agent. Currently all counties within ND pay 50% of the salary and 100% of operating expenses with NDSU paying 50% of salary and 100% of benefits. NDSU is proposing that the County's pay 40% of salary including benefits and 100% of operating expenses, with NDSU paying 60% of salary including benefits. More discussion will be needed.

BEER/LIQUOR LICENSES: On motion of Eblen, seconded by Amb and carried to allow the Chairman and Auditor to sign the 2018 ON SALE ONLY Beer license for Howlerz BBQ and Country Bistro in Mayville.

TAX DIRECTOR: Kayla Knudson, Tax Director presented the omitted property which had been tabled from the last meeting owned by O'Brien Seed Company, Mayville. Parcel numbers are: 06-0000-00936-020, 27-0039-00004-000, 27-0039-00004-000 and 27-0039-00003-000. On motion of Young, seconded by Eblen and carried, for the Tax Director and County Auditor to begin the process of Omitted Property. AMBULANCE: Charles Stock, States Attorney presented the board with updated contracts for F-M Ambulance and West Traill ambulance service. The contracts will be reviewed and presented at the next meeting for signatures.

LEC PROJECT: Bobbi Hepper-Olson and David Fyre updated the board on the Law Enforcement Center remodel project. We are 99% complete. On motion of Young, seconded by Amb and carried to approve the following payments: Diversified Contractor's Inc \$16,271.00 (holding \$2,500.00 until last items are completed), RBB Electric \$20,685.80 (final payment) and Precision \$2,000.00 (final payment).

SHERIFF: Steve Hunt, Sheriff presented the 2018 Hillsboro City Policing Contract. On motion of Amb, seconded by Eblen and carried to approve the contract with a correction to remove the section referring to an automatic renewal.
