The Traill County Commissioners came to order on February 6, 2018 at 8:00 a.m. with the following members present: Eblen, Young, Nesvig and Elliott, Les Amb present by conference call. MINUTES: On motion of Eblen, seconded by Nesvig and carried to approve the minutes of 01-16-18 as presented.

NOTICES: Farewell for Emily Cost will be held on February 20th from 10:00-11:00 a.m. in the Community Room. Also, the Vet's Club will be hosting an event for Emily on Tuesday, February 27th from 4:30-6:30. Auditor's office will be closed afternoon of March 6th & all day on March 7th for Haugen and Hovey to attend Election conference in Bismarck.

INSURANCE BIDS: On motion of Nesvig, seconded by Elliott and carried to allow the Auditor to advertise for 2018-2019 insurance bids. Opening of bids will be March 6, 2018 at 8:15 a.m. during Commission meeting.

PRELIMINARY BUDGET DEADLINE: NDCC 57-15-02.2 on or before August 10, 2018 all taxing entities must submit to the County Auditor a preliminary budget for 2019. Any taxing entity that fails to provide the information required under this subsection on or before August 10th, may not impose a property tax levy in a greater amount of dollars than was imposed by the taxing district in the prior year.

RAFFLE PERMIT: On motion of Eblen, seconded by Nesvig and carried to approve the raffle permit #289 for the Central Valley Public School-Technology Student Association. Drawing to be held on 03-22-18.

CONTRACT FOR DEEDS: On motion of Eblen, seconded by Nesvig and carried to allow the Chairman and Auditor to enter into a Contract for Deed with Ben Olson, Hillsboro on parcel #26-0002-06015-000 for property which had been foreclosed on. On motion of Amb, seconded by Elliott and carried to allow the Chairman and Auditor to enter into a Contract for Deed with Jay Burley, Mayville on parcel #27-0009-07414-020 for property which had been foreclosed on.

ECONOMIC DEVELOPMENT: Melissa Beach, EDC Director met with the Board. On motion of Nesvig, seconded by Eblen and carried to appoint Roxanne Phipps, Hatton; Rick Halvorson, Galesburg and Paul Geray, Hillsboro to the Traill County Economic Development Board with their terms to expire 12-31-2020.

HUMAN SERVICES: Kim Jacobson, HS Director met with the board. The Human Service Tax Relief SB2206 & NDCC 50-34-05 states the balance of monies in the fund on January 1st of each year may not exceed \$100,000.00. On motion of Eblen, seconded by Amb and carried to allow the County Auditor to transfer \$117,424.97 (the Human Service overage) into the General Fund to help with property tax relief.

HIGHWAY DEPARTMENT: Corwyn Martin, Road Superintendent and Matt Lange, KLJ met with the Board giving updates on various roads and bridge work. On motion of Amb, seconded by Nesvig and carried to allow the Chairman and Auditor to sign an agreement with Western Dakota Energy Association to implement a LOADPASS PERMIT system that will be governed by Western Dakota Energy Association. A registration cost of \$1500.00 and a yearly fee of \$500.00 will be assessed.

VSO: Rebecca Hodgson & Emily Cost, Directors met with the Board. Hodgson requested permission to attend the National Accreditation classes in South Dakota on August 20-24th. On motion of Nesvig, seconded by Elliott and carried to allow the request of out-of-state travel.

COUNTY AGENT: Alyssa Scheve, Co. Agent & Kim Ruliffson, East District Director for NDSU Extension Service gave updates for the Agent's office. The State is looking at restructuring the payment scale provided between the state and counties. Currently the counties pay 50% of salaries and the State paying 50% of salaries and 100% of benefits. The proposed change will be splitting the salaries and benefits with the county paying 40% and the state paying 60%.

With the proposed change, Traill County could be looking at an increase to the Co. Agent's budget of \$5,235.00. If the proposed change gets approved, it will take effect on January 1, 2019. Ruliffson informed the board that due to Federal cuts, Leigh Gunkel's position will be eliminated on June 30, 2018.

TAX DIRECTOR: Kayla Knudson, Tax Director met with the Board. On motion of Nesvig, seconded by Elliott and carried to allow the Chairman and States Attorney to sign a payment agreement with Reynolds United Co-Op in the amounts of \$58,504.11 for their 2015 taxes, due no later than 12-31-19 and \$58,873.91 for their 2016 taxes, due no later than 12-31-2020. Knudson informed the Board that Mel Carson, appraiser for Traill County's commercial property will be finishing up in 2019. Discussion was held on keeping Carson on as contract labor in order to keep up with the assessments on commercial property so we don't fall behind. Cost to keep Carson on would be no more than \$15,000 per year. Commissioners will look at the option during regular budget hearings.
