The Traill County Commissioners came to order on October 16, 2018 at 8:00 a.m. with all members present. On motion of Nesvig, seconded by Amb and carried to approve the minutes with a correction to the ditch cleaning permit filed by Les Amb, was typed as County Road #13 & #13, should read County Road #19 & #13.

TRANSFER: On motion of Amb, seconded by Eblen and carried to allow the County Auditor to transfer \$35,000.00 from the 911 Wireless Fund to E911 Regular Fund.

CONTRACT FOR DEED: On motion of Elliott, seconded by Nesvig and carried to allow the Chairman and Auditor to sign a Contract For Deed with Robert A. Andre for the West 60' of Lots 5 & 6 (less South 3' of Lot 5) Block 17, Original Townsite, Mayville City, parcel #27-0002-06788-000 as property had gone back to Traill County for nonpayment of taxes.

AMBULANCE CONTRACTS: On motion of Eblen, seconded by Amb and carried to allow the Chairman to sign the 2019 Ambulance contracts for West Traill, Mayville and F-M Ambulance Service, Inc. dba Hillsboro Ambulance Service.

DEPARTMENT REQUESTS: Paulette Bowersox, Clerk of District Court met with the Board. The Commissioners were in favor of allowing each department to purchase one shirt per employee with the Traill County logo on the front, as long as the departments do not overdraw their budgets.

HOLIDAYS: On motion of Amb, seconded by Nesvig and carried to approve the closure of the county offices on the following days: 12-24-18 and 12-31-18 to coincide with the regular holiday closures Christmas Day & New Year's Day.

RISK MANAGEMENT: Heather Hovey, Deputy Auditor- Risk Manager presented to the Board the 2019 Flex Plan and Workers Compensation Program and informed everyone that open enrollment is now on and they may make any changes for the new year. Hovey presented the 2019 ND Blue Cross/Shield dental and vision plans and rates to the Board. The only change to the dental plan was the monthly premium which resulted in a decrease of premiums. Discussion was held on the current vision plan which will have an increase in premiums of \$2.10 per employee & \$6.40 per family plan. Hovey introduced an upgrade to our vision plan resulting in additional coverage for the employees and their families. On motion of Amb, seconded by Eblen and carried to upgrade the vision plan resulting in additional coverage and a small increase in premiums.

HIGHWAY DEPARTMENT: Corwyn Martin, Road Superintendent and Matt Lange, KLJ met with the board on various matters. Martin informed the board that an insurance company is requesting an estimate before a claim can be filed with the driver who damaged bridge #424, Swingen Construction will be providing a quote. On motion of Amb, seconded by Elliott and carried to allow the States Attorney, Auditor and Chairman to sign the ND DOT Maintenance Certification County Federal Aid Project Form. Martin informed the board that the county has received approximately \$1500.00 thru the Load Pass Permit overload program. Discuss on the oil revenue money that the Legislature would have to approve before it is sent to non-oil bearing counties. On motion of Amb, seconded by Elliott and carried to hold the payment for Zavoral Construction in the amount of \$745,776.69 until we have received the money from the State. Ken Nesvig informed Martin that County Road #17 is in dire need of some repairs. Martin explained that he is waiting until we hear back from the grant because the repairs would be included in the grant. Lange notified the board that there is approximately \$150,000 in additional Federal dollars available to Traill County from funds unused by other states. No word on the Build Grant at this time, but we should hear back by December 15, 2018. The Climax Bridge was discussed. Design and repairs could be upwards of \$160,000.00 with Traill having to pay \$80,000.00.

Lead paint could be a factor in the cost of repairs. On motion of Nesvig, seconded by Amb and carried to allow KLJ to advertise for quotes too repair the bridge. Lange will do some research on how to remove structures from a Historical Register.

SHERIFF: Steve Hunt, Sheriff informed the board that the cost of replacing a patrol car will be increasing. Hunt will check with other counties and dealerships for costs and State bids.
