The Traill County Commissioners came to order on December 4, 2018 at 8:00 a.m. Commissioner Elliott was absent from the meeting. On motion of Eblen, seconded by Amb and carried to approve the minutes of the special meeting held on November 15, 2018 as printed. On motion of Nesvig, seconded by Eblen and carried to approve the minutes of November 20, 2018 as printed.

F-M AMBULANCE CONTRACT: On motion of Eblen, seconded by Nesvig and carried to allow the Chairman to sign the amended ambulance contract as presented.

SOCIAL SERVICE: On motion of Amb, seconded by Eblen and carried to allow the Social Service Department advertise for the sale of their 2007 Ford Crown Victoria, with bids to be open on 12-18-18 at 8:20 a.m.

CORRESPONDENCE: Received an invitation to attend the County Christmas Potluck & make a donation to the food pantry on 12-12-18 at noon.

TAX DIRECTOR: Kayla Knudson, Tax Director presented the list of modifiers she uses. On motion of Eblen, seconded by Nesvig and carried to accept the modifiers as presented. On motion of Eblen, seconded by Nesvig and carried to approve an abatement filed by Charles Stock for parcel #26-0038-00002-000 reducing his valuation by \$22,000.00 for the 2018 tax year, as proper notification was not given. The valuation on Stock's property will be increased for the 2019 tax year. On motion of Amb, seconded by Nesvig and carried to allow Knudson to add the following parcels to the tax list as omitted property: parcel #28-0005-07772-000 property owned by The Press Box; Parcel #07-0000-00989-010 property owned by Paul & Janet Hoffart; parcel #07-0000-01032-030, property owned by Jeremy Jennen and parcel #07-0000-01075-001, property owned by David & Nancy Johnson.

HIGHWAY DEPARTMENT: Corwyn Martin, Road Superintendent and Matt Lange, KLJ gave updates to the board. On motion of Amb, seconded by Nesvig and carried to allow the Chairman to sign a letter of support and a letter of financial support for the Competitive Highway Bridge Grant Program for the Nielsville and Hendrum bridges in Traill County. This grant is being written by the MN DOT. Martin was contacted by Jason Benson, Cass County for input to increase the road limit along Hwy 81/CR 25 in Traill County from the current limit of 105,500 to 129,000. After much discussion, the commissioners agreed at this time, to leave the 105,500 road limit as is.

TC ECONOMIC DEVELOPMENT: Jim Murphy, TCEDC Director presented a list of potential names for consideration to the TCEDC Board. On motion of Eblen, seconded by Nesvig and carried to appoint David Johnson (pending his approval), Kurt Elliott, Ben Hershey and Scott Hovde to the 2019 TCEDC Board.

DISTRICT COURT: Paulette Bowersox, Clerk of District Court and Jenni Rubash, Custodian presented the 2019 Court Facilities Improvement Grant. The grant would replace three air conditioning units which totals \$13,700.00, with a cost to Traill County of \$3425.00 (25%). Rubash also mentioned there may be additional costs to the county of approximately \$2000.00 for repairs to the courtroom walls if damaged. On motion of Amb, seconded by Eblen and carried to approve the Chairman to sign the grant.

SHERIFF: Steve Hunt, Sheriff asked for permission to advertise for an E911 Dispatcher, as Emily Grothmann had resigned. On motion of Amb, seconded by Eblen and carried to grant Hunt's request. Hunt discussed the vacation hours accumulated by the E911 Dispatchers due to lack of employees to cover shifts. On motion of Eblen, seconded by Nesvig and carried to allow the E911 Dispatchers to carry over their accumulated vacation hours into 2019, with the stipulation, the vacation hours will need to be used by December 4, 2019 (one year).
