The Traill County Commissioners came to order on October 1, 2019 at 8:00 a.m. with the following members present: Commissioners Elliott, Nesvig, Amb and Young. Commissioner Eblen absent. On motion of Nesvig, seconded by Young and carried to approve the minutes of 09-17-19 as presented.

CORRESPONDANCE: (1) 2020 Federal Aid projects for highways and bridges (2) ND DOT letter on safety for rail/highway crossings (3) Comparison sheet on State & County Tax Levies for 2018 & 2019

WEST TRAILL AMBULANCE: Discussion on the 2020 Ambulance contract to add that a yearly audit will be submitted to the Commissioners. Tabled until next meeting.

HUMAN SERVICE ZONE: Kim Jacobson, Human Service Director presented an Addendum 1 to the Human Service Zone Agreement. On motion of Young, seconded by Elliott and carried to approve the Addendum.

STATE FAIR: On motion of Elliott, seconded by Nesvig and carried to appoint Tom Eblen and Larry Young as delegates to the State Fair Association.

HIGHWAY DEPARTMENT: Corwyn Martin, Road Superintendent and Matt Lange, KLJ updated the board on various issues. On motion of Nesvig, seconded by Young and carried to allow the States Attorney, Commission Chairman, Auditor and Road Superintendent sign the ND DOT Maintenance Certification County Federal Aid Project agreement. Martin informed the board that due to the wet conditions, some bridge and dirt work has been put on hold. Commissioners asked Martin to discuss declaring a disaster for all the water/flooding and requested Martin to talk with Steve Hunt, DES Director and Charlie Stock, States Attorney. Martin has been in contact with township supervisors to report any rail road crossing issues. On motion of Nesvig, seconded by Elliott and carried to approve an \$8,000 repair to bridge 416 to get it open this year, and do some permanent repairs next year.

COURTHOUSE PARKING LOT: Jenni Rubash, Custodian and Matt Lange, KLJ presented quotes received on the parking lot addition. Two quotes were received: Option A: Opp Construction \$155,542.00 and Boarderstate \$148,143.00 Option B (concrete): Opp Construction \$ 188,299.00 and Boarderstate \$196,711.00. After much discussion, on motion of Nesvig, seconded by Elliott to reject all quotes and bid out the project this fall to coincide with our paving projects next year.

DAKOTA NATURAL GAS: Jim Murphy, TC EDC Director and Paul Geray, Vice-Chair TC EDC discussed the grants available to help the County convert the boilers over to natural gas. Murphy presented several grant options available for energy efficient upgrades and informed the commission his office would help with completing grant applications. Glenda Haugen, Auditor received estimates from Greg Palmer, Dakota Natural Gas for the year 2018, our cost would have been approximately \$15,500.00 if we were using natural gas. The amount the county spent for fuel at the courthouse and the highway department in 2018 was \$45,400.00. Murphy gave a copy of a letter he is sending out to the businesses and residents in Traill County hoping for their input on the subject. The Commissioners tabled the subject until the next meeting.

TAX ABSTRACT: Certification from Ryan Rauschenberg, State Tax Commissioner informing the board that Traill County is in compliance and has approved Kayla Knudson, Tax Director's tax abstract for the 2019 tax year with no changes.

COUNTY PARK: Glenda Haugen, Auditor informed the board that the park expenses as of today are \$7,073.95 and income is \$4,300.00. The park is officially closed for the season. Haugen will contact utilities.

SHERIFF: Steve Hunt, Sheriff discussed declaring an emergency with the board. He will contact Charlie Stock and Corwyn Martin and bring back to the next meeting.
