BEER/LIQUOR LICENSE: On motion of Amb, seconded by Eblen and carried to approve two application requests from Craig Conner and The Barn & Grill Bar, Buxton to move their ON-Sale Only liquor & beer licenses to the Kris Huebner farm located at 14881 13th St NE Buxton. The dates for the move are August 19, 2017 and September 1, 2017.

CORRESPONDENCE: Received a copy of the 1990 County Park and Game & Fish agreement. Commissioner set August 29, 2017 as the day to meet with department heads on their 2018 budget. Registration for the upcoming NDACo Convention October 8-10 will be completed by Auditor.

TREE STOCK PILE: A request from Levi Mattson to use some of the fallen trees stockpiled on County property for his Eagle Scout project is on hold pending proof of liability insurance.

RAFFLE PERMIT: On motion of Young, seconded by Amb and carried to approve the Raffle Permit submitted by Normal Lutheran Church with raffle to be held on October 25, 2017.

SOCIAL SERVICES: Kim Jacobson, Director and Joe Kramer, Remark Technology met with the Board. On motion of Amb, seconded by Young and carried to allow the Chairman to sign the copy machine maintenance agreement. On motion of Amb, seconded by Elliott to allow an increase in bandwidth for the computer system within the county with the increase of \$370.00 per month being paid out of the Oasis Fund. Joe Kramer was instructed to monitor the increase and make sure the issues with the computer system will be resolved by increasing the bandwidth.

DRAIN BOARD: Jason Siegert and Andy Neset of the TC Water Resource District along with Brady Woodard and Chris Gross of Moore Engineering met with the board concerning the clean out of the Murray Drain #17 in Norway Township. Concerns have risen about the steep slope on the edge of the drain which could cause serious damage to vehicles and individuals. The Water Board will look into the possibility of smoothing out the side of the ditch.
