FALLEN TREES: On motion of Amb, seconded by Elliott and carried to allow Levi Mattson of Hillsboro to remove some of the fallen trees from the July 11th storm, to build dog shelters down at the Hillsboro Park.

AMBULANCE CONTRACT: A meeting will be scheduled in November with West Traill and F-M Ambulance to review and approve the 2018 contract.

INDEMNITY BOND: On motion of Elliott, seconded by Young and carried to approve the Indemnity Bond for Lost Instrument filed by Mayville City for check #91755, dated 08-02-17 in the amount of \$441.44.

JAIL REMODEL PROJECT: Bobbi Hepper-Olson & David Fyre met with the Board. Updates on the project were given. On motion of Young, seconded by Elliott and carried to approve the change orders as presented.

HIGHWAY DEPARTMENT: Corwyn Martin gave the board updates on various projects. Martin requested to have the road department's credit card limit increased to \$5000.00. On motion of Amb, seconded by Eblen and carried to change the county credit card policy to allow the Road Department to have a credit card with a limit of \$5000.00. On motion of Amb, seconded by Elliott and carried to approve a Driveway Permit submitted by Rust Farms for a new approach located on the south side of county road 11 between 161st Ave SE & 162nd Ave SE, Hillsboro ND. Matt Lange and Kris Bakkegard, KLJ gave the board updates. Informed the commission approval has been received to complete project #CNOB-CNOC-4919(056) with the final payment being mailed to the Bonding Company: North American Specialty Insurance Company. On motion of Amb, seconded by Elliott and carried to allow Chairman Nesvig to sign the Professional Agreement with KLJ, in the amount of \$9,500.00 for Bridge 280 & Bridge 2 Hydraulic Analysis.
