The Traill County Commissioners came to order on September 19, 2017 at 8:00 a.m. with the following present: Commissioners Amb, Elliott, Nesvig and Young by phone, Commissioner Eblen absent.

MINUTES: On motion of Elliott, seconded by Amb and carried to approve the minutes of September 5, 2017 as presented.

RAFFLE PERMIT: On motion of Amb, seconded by Elliott and carried to approve the raffle permit filed by Central Valley School for 50/50 drawings.

LIQUOR/BEER LICENSES: On motion of Elliott, seconded by Amb and carried to approve the ON SALE ONLY liquor and beer licenses for Barn & Grill, LLC, owner Craig Connor to be located on the Kris Huebner farm on 4.57 Ac Tract in SE1/4SE1/4 26-148-53.

CAPITAL ASSET POLICY: On motion of Amb, seconded by Elliott and carried to approve the updated Capital Asset Policy for Traill County.

LODGING RATES: On motion of Elliott, seconded by Amb and carried to approve the County's lodging rates as of 10-01-17 to be \$83.70.

COUNTY ROAD 25: Mark Cutshaw met with the board with concerns about the early beet harvest and the dust control on County Road 25 by his house. Kevin Sondreal also attended the meeting and explained that the dust control solution will be applied in early October, waiting for the full beet harvest to begin. The dry season has not helped the situation and with the cost of applying the solution that is all they can do. Corwyn Martin, Road Superintendent has been in contact with Grand Forks County and between the two counties; they will use their water trucks to help with dust control.

HIGHWAY DEPARTMENT: Corwyn Martin, Road Superintendent and Matt Lange, KLJ met with the board giving updates on various projects. The 2018-2022 County Federal Aid Program was tabled until October 3, 2017 giving Corwyn & Matt time to review. The ND DOT offered to lease the Mayville DOT shop for \$3,250.00 for a period of one year. On motion of Elliott, seconded by Amb and carried to decline the lease contract with the ND DOT. Martin informed the commission that Ross Johnson did not obtain a drain tile permit along County Road 21 in section 31 of Buxton Township. The Commission advised Martin to contact the States Attorney to draft a letter to Mr. Johnson. On motion of Amb, seconded by Elliott and carried to approve the ditch cleaning permit submitted by Ken Grinde along County Road #11, in the SE ½ 21-146-53. On motion of Elliott, seconded by Amb and carried to approve the ditch cleaning permit submitted by Richard Camrud along County Road #81, in Section 18, Stavanger Township. On motion of Elliott, seconded by Amb and carried to open gravel bids. One gravel bid was received from KRB, Mayville. On motion of Amb, seconded by Elliott and carried to accept the gravel bid of KRB in the amount of \$10.50 per yard for crushed gravel.

TIGER GRANT/NIESLVILLE BRIDGE: Commissioner Amb introduced the following resolution and moved its adoption, which was seconded by Commissioner Elliott:

WHERAS, Transportation is a vital part of Traill County's infrastructure and adequate transportation facilities are essential to sustain and maintain the social and economic wellbeing of the area; WHERAS, The Consolidated Appropriations Act, 2017 (Pub. L. 115-31, May 5, 2017) appropriated \$500 million to be awarded by the Department of Transportation for National Infrastructure Investment for TIGER Discretionary Grants.

NOW, THEREFORE, BE IT RESOLVED, the Traill County Board of Commissioners agrees to serve as a coapplicant for a TIGER Discretionary Grant application with Polk County, Minnesota on the Multi-State Regional Connectivity Project. Agreeing to be a co-applicant includes a willingness to secure and guarantee the local share of costs associated with this project and responsibility for seeing this project through to its completion, with compliance of all applicable laws, rules and regulations. **BE IT FURTHER RESOLVED,** the Traill County Board of Commissioners authorizes the submittal of TIGER Discretionary Grant application for the Multi-State Regional Connectivity Project.

Upon roll call vote being taken thereon, the following Commissioners voted Aye: Elliott, Amb, Young and Nesvig, Nay: None. Absent from meeting and not voting, Commissioner Eblen.

On motion of Amb, seconded by Elliott and carried to allow Chairman Nesvig and Auditor Haugen to sign the Federal Wage Rate Certification letter for the TIGER Grant. On motion of Elliott, seconded by Amb and carried to allow Chairman Nesvig and Auditor Haugen to sign the Letter of Matching Funds stating that Traill County will commit to 10 percent of the total project cost should the TIGER Grant be awarded.

SOCIAL SERVICES: Kim Jacobson, Director met in person with the board along with States Attorney Charles Stock by phone concerning the email Chairman Nesvig received from Paula Suda, Superintendent of Hillsboro Public School. The email indicated there were concerns about Jacobson having the right credentials to hold the position as Director of Traill County Social Services. Jacobson presented documents from ND DHS, including her original application and supporting documents indicating Jacobson is qualified and was approved by ND DHS and the Traill County Social Service Board to hold the position of Director of Social Services. All documents have been forwarded to Paula Suda and are on file under open records law in the Auditor's Office. Jacobson informed the board that Shantel Chase, Family Service Specialist III has resigned her position and will be transferring to Ransom County on September 30, 2017. On motion of Amb, seconded by Elliott and carried to allow Jacobson to advertise the position for a Family Service Specialist. Jacobson updated the board on the increase of bandwidth which has greatly improved her office's ability to complete their projects.

CO AGENT: Alyssa Scheve, County Agent met with the board and asked for funding to help with repairing two 4-H Quonsets. Traill County will be receiving \$4,456.33 from NDIRF for the damage to the middle Quonset during the July 11, 2017 storm. The 4-H Council is prepared to pay for the \$1,000 deductible on this project. The commissioners present requested that Scheve bring this matter to the October 3rd meeting when we have a full commission board present.
