The Traill County Board of Commissioners came to order on February 3, 2015 at 8:00 a.m. with all members present.

On motion of Amb, seconded by Larson and carried to approve the minutes of January 20, 2014 as presented.

On motion of Larson, seconded by Elliott and carried to allow the County to enter into a contract with The Village Business Institute for the county EAP program for 2015 at a cost of \$2,010.00.

On motion of Elliott, seconded by Amb and carried to allow the Chairman and County Auditor to sign a County Deed with Steven P Eliason for E 45' of Lots 7, 8, 9, & 10, Block 11 Original Townsite, Portland City.

On motion of Larson, seconded by Elliott and carried to allow the County to sign the Maintenance Certification for County Federal Aid Projects with NDDOT.

Marlene Eblen, County Recorder met with the commission to introduce Tiffany Ambuel as her new Deputy. The commission welcomed Tiffany.

Steve Hunt, Sheriff met with the commission on various matters. He asked permission to be allowed to purchase \$300.00 worth of body armor from Pembina County for Brian Enrich the new deputy. He also asked permission that Tony Ernst be named the Assistant DES Director. He also asked for more Cenex Credit Cards to be put in all vehicles, the commission granted the request. Hunt also asked permission to get a new copy machine equipped with a fax, scanner in the office at a cost of \$95.00 per month including maintenance. On motion of Amb, seconded by Elliott and carried to allow the request of Hunt.

Cory Martin, Road Superintendent met with the commission on various matters. Naastad Brothers will get the county a quote on the removal of the building owned by the county on Lot 5, Block 40 Original Townsite of Hatton. He also informed the Commission that he had received word from NDES that the county will receive \$60,131.75 from 2010 FEMA for Non FAS Roads and Bridges. Martin also stated that he had been in contact with the state to put rail crossings on CR #3 and 81 in Kelso Township. On motion of Amb, seconded by Elliott and carried to allow Cory Martin, Road Superintendent to be allowed to sign the contract in the amount of \$3,000 to \$5,000 for the study to repair Bridge #276. He also asked permission to be allowed to purchase a new crack sealing machine at a cost of \$45,350.00. On motion of Amb, seconded by Larson and carried to allow Martin to purchase the machine.

Patrons of Bridge #220 met with the commissioners concerning the texas crossing. Chad Hanson, acting a spokesman for the group asked the commission how it will fit into the county's priority list. The commission informed the group that they had no forgotten about the bridge and that it will continue to remain on the list.

John Wright, Office Manager Road Department met with the commission concerning the software program out at the road department. The current program that the department is using has two separate programs and the new program that the road department would like to use

would combine the two programs together. The commission gave approval for the Road Department to try the program provided by Peridox One and return after they have tried the program out.

Kim Jacobson, Social Service Director met with the commission concerning the lease agreement with Wells Fargo Bank for a two year period starting November 1, 2015. On motion of Elliott, seconded by Larson and carried to allow the county to enter into the lease. Lease to expire October 31, 2017.

Melissa Beach, TCEDC Executive Director met with the commission to present three names for commission approval to the Traill County Economic Development Board of Directors. On motion of Larson, seconded by Amb and carried to approve the names of Rick Halvorson, Galesburg; Roxanne Phipps, Hatton and Stuart Larson, States Attorney to the Board of Directors all terms to expire December 31, 2017.
