The Traill County Commissioners came to order on March 3, 2020 at 8:00 a.m. with the following members present: Commissioners Eblen, Young, Elliott and Nesvig. Commissioner Amb by conference call. On motion of Nesvig, seconded by Elliott and carried to approve the minutes of 02-18-20 as presented.

SHERIFF: Steve Hunt, Sheriff presented a 2020 Spring Emergency Disaster Declaration due to expected flooding. On motion of Amb, seconded by Young and carried to allow the Chairman and Auditor to sign the declaration. Hunt informed the commission he will be discussing the ND State 2020 Siren Project at the March 17th meeting.

LIQUOR/BEER LICENSES: On motion of Young, seconded by Elliott and carried to approve the ON SALE ONLY liquor and beer licenses for The Goose River Golf Club. Licenses to run May 1, 2020 to November 30, 2020.

DOME REPAIRS: On motion of Nesvig, seconded by Young and carried to allow the Chairman to sign the Phase 1-Upper Dome Area Repair contract, in the amount of \$125,468.00, with General Roofing & Construction, Carrington. On motion of Elliott, seconded by Nesvig and carried to approve the 1st payment request in the amount of \$18,820.20 to General Roofing & Construction. On motion of Young, seconded by Amb and carried to allow the Auditor to sign the Cultural Heritage Grant Award Agreement with the ND State Historical Society. The grant is for phase one of the Upper Dome repairs and is in the amount of \$50,000.00 with a final date of paperwork submission 05-31-21.

INSURANCE BIDS (Policy year 04-01-20 to 04-01-21): Lee Erickson, Erickson Agency, Inc. met with the board. On motion of Nesvig, seconded by Young and carried to open the only bid received from Erickson Agency/Viking Insurance & Realty. On motion of Young, seconded by Elliott and carried to accept the bid from Erickson Agency/Viking Insurance & Realty in the amount of \$68,526.00, which includes a \$2 million liability package, all vehicles and a comprehensive boiler & equipment policy through NDIRF. The policy holds a \$1500.00 deductible.

HIGHWAY DEPARTMENT: Corwyn Martin, Road Superintendent presented a permit filed by Joe Dufner for a driveway access along Highway 21, east side of Buxton, in section 25 Stavanger Township. On motion of Elliott, seconded by Nesvig and carried to allow the Chairman to sign the permit. Galesburg Elevator has requested a load limit increase to 105,500 for a ¼ mile stretch of highway from the new fertilizer plant to the highway. On motion of Elliott, seconded by Nesvig and carried to allow Corwyn Martin to "sign" the road to 105,500. Martin will monitor the road for damage and if problems arise, the limit will be reduced. Martin informed the board that the new railroad crossing signal light along County Road 3 is in the process of being built. Discussion was held on the Nielsville bridge. New grants are due in March 2020 should Traill County want to go forward with trying for another grant. Ken Nesvig motioned to hire KLJ Engineers to submit the new grant with a total cost of \$7500.00. Polk County and Traill County each paying \$3,750.00, motion died for lack of a 2nd. On motion of Amb, seconded by Young and carried to allow Martin to place spring load restrictions on when necessary. Martin will have his crew start cleaning any drainage issues that arise. The Nielsville Bridge was discussed again. The cost is less because KLJ Engineers said most of the paperwork was completed with the last grant. On motion of Nesvig, seconded by Amb to hire KLI Engineers to submit the new grant with a cost of \$3,750.00 to Traill County, pending approval by Polk County in Minnesota. Upon roll call vote Commissioners voting age: Eblen, Nevig, Amb, Commissioners voting nay: Elliott and Young, motion carried. On motion of Elliott, seconded by Young and carried to appoint Tom Eblen, Corwyn Martin, Charlie Stock and Matt Lange to a committee to meet with Hillsboro City concerning the Riverwalk Addition.

COUNTY DONATION POLICY: Kim Jacobson, Agassiz Valley Human Service Zone Interim Director presented a Traill County Donation Policy to the Board. NDCC 1-08-04 allows for entities to accept gifts, such as quilts and monetary donations and give them to those in need, however the law did not include the language to allow the Human Service Zones to accept gifts. Until the law is changed, Traill County needs to have a policy in place to allow the Human Service Zone Department to receive, inventory and track all donations given. Glenda Haugen, Auditor will establish an account for monetary gifts. On motion of Young, seconded by Nesvig and carried to approve the policy as presented. Haugen will notify all Traill County offices of the policy.
