Commission Chairman Thomas Eblen called the meeting to order.

CORONAVIRUS UPDATES: TC Health District Director, Brenda Stallman gave updates. N95 masks have been received and fit testing is done. Testing of the virus continues.

WORKING FROM HOME: TC States Attorney Charlie Stock, requested the Commissioners to leave the hours as is and allow the employees to work from home if possible. Offices submitted their individual work from home solutions. TC DES Assistant Ben Gates read the COVID-19 Remote Work Policy Recommendation. On motion of Nesvig, seconded by Amb and carried to approve the following motion: Traill County offices will move to one (1) person offices effective 04-06-20 and to continue until further review/notice by the local Commission or anyone who can work from home, should work from home effective 04-06-20 and to continue until further review/notice by the local Commission. Anyone at home is required to continuously follow the ND Dept of Heath and CDC guidance (i.e. stay at home/social distancing policies, etc). These individuals will be required to be home and available during business hours. Department heads will have authority to decide how this effects their individual offices and determine proper work schedules (such as staggering schedules) to meet the capabilities for their office while maintaining all ND Dept of Health and CDC guidelines. Any questions from the Department Heads on this policy should consult their Commission Portfolio Holder and the Commission Portfolio Holder would have final decision authority.

EMPLOYEE POLICY: On motion of Amb, seconded by Nesvig and carried to have all Traill County employees read and sign a "Prevention of Spread of Coronavirus in the Workplace" policy presented by Stallman. HR will distribute the policy and collect signatures, which will be placed in employee's files.

FLOOD UPDATES: Sheriff, Steve Hunt updated the Commission on the current flood situation. Several bridges and roads have been closed and expect less flooding as originally expected, pending any new precipitation. Notices of closed bridges and roads will be placed on the Facebook & Website pages.

ELECTION UPDATES: Auditor Glenda Haugen gave updates on the Primary Election coming up in June. As of today, 1,571 applications for a mail-in ballot have been received. The last Presidential election in June 2016 we had a total of 1,870 voters. Secretary of State's office will be mailing out a second round of applications, to make sure everyone has a chance to vote.
