The Traill County Board of Commissioners came to order on July 21, 2015 at 8:00 a.m. with all members present.

On motion of Amb, seconded by Larson and carried to approve the minutes of July 7, 2015 as amended.

On motion of Larson, seconded by Nesvig and carried to allow the county to reissue Auditors Warrant #82207 in the amount of \$14.00 to Jay Showers as an Indemnity Bond for Lost Instrument has been filed.

On motion of Larson, seconded by Elliott and carried to allow the Chairman to sign the Reappraisal Proposal for Commercial Property in Traill County with Mel Carsen, Carsen Appraisal Services.

On motion of Larson, seconded by Nesvig and carried to approve a raffle permit for Bodhi Billings Benefit. Event to be held 8/29/2015.

On motion of Amb, seconded by Nesvig and carried allow the Chairman and County Auditor to sign the Model "B" Floodplain Ordinance with the State of North Dakota for the new Flood Insurance Rate Maps.

Commissioner Amb introduced the following resolution and moved its adoption which motion was seconded by Commissioner Nesvig:

BE IT RESOLVED by the Board of County Commissioners that banks in the county be designated depositories of public funds in the custody of the County Treasurer and in an amount not to exceed FDIC Certificates as follows, to wit: Wells Fargo-Hillsboro; Goose River Bank, Hillsboro, Mayville & Hatton; Farmers & Merchants-Hatton; First & Farmers Bank, Portland & Mayville; First State Bank, Buxton; Dakota Heritage Bank-Hunter, Galesburg Branch & Hillsboro Branch (for such amounts as the county may find necessary).

BE IT FURTHER RESOLVED that pledges as assets in the county \$1,940,584 Wells Fargo: \$3,894,345 Goose River Bank, Hillsboro, Mayville & Hatton: \$415,000 Farmers & Merchants National: \$6,400,000 First & Farmers Bank: \$5,250,000 First State Bank: Dakota Heritage Bank-Hunter Galesburg Branch & Hillsboro Branch: \$355,000, Galesburg Branch & Hillsboro Branch are hereby approved for additional deposits by the County Treasurer in excess of FDIC Certificates \$250,000 as of June 30, 2015.

The following members were present and voted aye for the adoption of the foregoing resolution: Eblen, Elliott, Nesvig, Larson and Amb. The resolution was declared adopted.

On motion of Nesvig, seconded by Larson and carried to cancel the following Auditor's warrant #79331 dated 05-21-13 \$75.00; Treasurer's check #26607 dated 05-02-13 in the amount of \$6.38 and that amounts be sent into the state to be placed in the unclaimed property fund.

Cory Martin, Road Superintendent met with the commission on various matters. He explained that the county road crew had been tarring and it rained right after the tar was put down and 3

vehicles needed to be cleaned by county forces to remove the tar. He gave an update on the summer chip sealing projects stating that they are closing up on the project. He also informed the commission that bridge #107A located between Section 31 & 32 of Kelso Township just north of Cass County Rd #11county forces will be installing 2 30" pipes. He also presented a ditch cleaning permit and a drive permit filed by Dennis Peterson. On motion of Elliott, seconded by Amb and carried to approve the ditch cleaning permit along CR #8 in Section 22 of Bohnsack Township as presented. On motion of Elliott, seconded by Larson and carried to approve the drive permit along the east side of CR #8 located ¼ mile from CR #1 in Section 22 of Bohnsack Township.

Brenda Stallman, Health District Director and Kelly Radabaugh, Tobacco Coordinator met with the commission to give them an update on what has been going on in Public Health. Stallman asked the commission to consider change the wording of the current policy to include all tobacco products. The commission asked that Stallman and Radabaugh write what they would like a policy to look like and return to the commission for a final decision.

Matt Lange, KLJ met with the commission to give them an update on what is happening this summer with the CR #14 project and the Bridge #220 project. He also presented a Short Form of Agreement between Owner and Engineer for Professional Services for the Bridge #220 project. On motion of Nesvig, seconded by Elliott and carried to approve the agreement in the amount of \$64,350.00 as presented.

Steve Hunt, Sheriff met with the commission on various matters. He presented a grant from the NDDOT for the purchase of new Radar/Lidar Equipment which will be reimbursed at 75% of the cost up to \$1,500.00 per unit. On motion of Larson, seconded by Nesvig and carried to allow the county to sign the agreement with the county share being \$393.00. He also presented an example of an administrative leave policy for those uncommon stressful situations. Hunt would like to the fees charged for fingerprinting the general public from the current \$10.00 to \$25.00. On motion of Amb, seconded by Larson and carried to allow the increase from \$10.00 to \$25.00 effective August 1, 2015.

Randy Kingsley, Executive Director and Amber Schaan, Assistant Director of the Lake Agassiz Regional Council met with the commission to introduce themselves as the new leadership of the Council.

On motion of Larson, seconded by Nesvig and carried allow the county to budget for the additional 10 mills on the Farm-to-Market Road fund. The additional 10 mills was voted on by the citizens at the last general election.

Stuart Larson, States Attorney informed the commission that the abandon Morgan Cemetery site is in need of attention. The commission directed Commissioner Amb to talk to Cory Martin to see if the employees of the Road Department could take care of this matter.

Kim Jacobson, Social Service Director met with the commission to ask permission to fill a position vacancy occupied by Lynn Schultz as an Eligibility Worker I. On motion of Larson, seconded by Amb and carried to allow the position to be filled.

The commission discussed the budget of the Farm to Market Road Fund for the upcoming 2016 budget year and the 2015 tax year. The citizens of Traill County had voted in the last general election to increase the levy up to an additional 10 mills. After discussing the matter at great length and Commissioner Larson made the motion, which was seconded by Commissioner Nesvig to levy the additional 10 mills for tax year 2015. Motion carried.
